It is expressly agreed and understood by and between the parties hereto that in the event of the transfer of title of the above described property or any part thereof without first obtaining a written consent from the Mortgages he ein, the entire unpaid balance of the indebtedness secured hereby shall then become due and payable in full.

To secure performance of the other agreements in said note, which are hereby incorporated herein and made a part hereof, and which provide, among other things, for an additional monthly payment of one-twelfth (1/12th) of the estimated annual taxes, assessments, insurance premiums and other charges upon the mortgaged premises. And to secure possible future advances as hereinafter provided and to secure the performance of the Mortgagor's covenants herein contained.

A. THE MORTGAGOR COVENANTS:

Such insurance policies, including additional and renewal policies shall be delivered as its interest may appear.

(3) To promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or destroyed; to keep said premises in good condition and repair, and free from any mechanic's or other lien or claim of lien not expressly subordinated to the lien hereof; not to suffer or permit any unlawful use of or any nuisance to exist on said property nor to distinish nor impair its value by any act or omission to act; to comply with all requirements of law with respect to the mortgaged premises and the use thereof;

(4) That II the Mortgagor shall procure contracts of insurance upon his life and disability insurance for lies of time, by accidental injury or sickness, or either such contract, making the Mortgagee assignee thereunder, the Muttgagee may the premiums for such insurance and add said payments to the principal indebtedness secured by this mortgage is be repaid in the same manner and without changing the amount of the monthly payments, unless such change is by mutual THIST.
