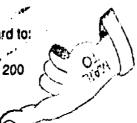

TOGETHER with all buildings, improvements, fixtures or appurtenances now or hereafter erected thereon, including all apparatus, equipment, fixtures or articles, whether in single units or centrally controlled, used to supply heat, gas, air conditioning, water, light, power, refrigeration, ventilation or otherwise and any other thing now or hereafter therein or thereon the furnishing of which by lessors to lessees is customer; or appropriate, including screens, window shades, storm doors and windows, floor coverings, screen doors, venetian blinds, in-order beds, awnings, stoves and water heaters (all of which are declared to be a part of said real estate whether physically attacked thereto or not); and also ingether with all easements and the rents, issues and profits of said premises which are hereby pledged, assigned, transferred and set over unto the Mortgagee.

TO HAVE AND TO HOLD all of said property unto said Mortgages for or, for the uses herein set forth, free from all rights and benefits under the Itomestead Exemption Laws of the State of I lineds, which said rights and henefits said Mortgages does hereby release and waive.

TO SECURE the payment of a certain indebtedness from the Mortgagor to the Mortgagee evidenced by a more made by the Mortgagor in favor of the Mortgagee, bearing even date herewith in the sun of TWENTY-FIVE THOUSAND AND NO/100---- Dot are (\$ 25,000.00), which note, (4) together with interest thereon as provided by said note, is payable in monthly installment; of .TWO HUNDRED.

It is expressly agreed and understood by and between the parties hereto that in the event of the transfer if title of the above described property or any pare thereof without first obtaining a welten consent from the Mongagee herein, it infire unpaid balance of the indebtedness secured hereby shall then become due and payable in full.

To secure performance of the other agreements in said note, which are hereby incorporated herein and made a part hereof, and which provide, among other things, for an additional monthly payment of one-twelfth (1/12th) of the estimated annual taxes, assessments, insurance premiums and other charges upon the mortgaged premiums. And to accure possible future advances as hereinafter provided and to accure the performance of the Mortgagor's covenants herein contained.

A. THE MORTGAGOR COVENANTS:

(1) To pay immediately when due and payable all general taxes, special taxes, special assessments, water charges, service charges and other taxes and charges against said property, including those heretofore due, (the monthly nay-provided by said note in anticipation of such taxes and charges to be applied thereto), and to furnish the Mortgagee, request, with the original or duplicate receipts therefor.

(2) To keep the improvements now or hereniter situated upon said premises insured against loss or damage by fire, lightning, windstorm and such other hazards, including liability under laws relating to intoxicating liquors and including hazards not now contemplated, as the Martgagee may reasonably require to be insured against, under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby, in such companies, through such agents or brokers, and in such form as shall be satisfactory to the Mortgagee. Such insurance policies, including additional and renewal policies shall be delivered to and kept by the Mortgagee and shall contain a clause satisfactory to the Mortgagee making them payable to the Mortgagee as its interest may appear.

(3) To promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or destroyed; to keep said premises in good condition and repair, and free from any mechanic's of other lien or claim of lien not expressly subordinated to the lien hereof; not to suffer or permit any unlawful use of or any misence to exist on said property our to diminish nor impair its value by any act or omission to act; to comply with all requirements of law with respect to the mortgaged premises and the use thereof;

(4) That if the Mortgaget shall procure contracts of insurance upon his life and disability insurance for less of time by accidental injury or sickness, or either such contract, making the Mortgagee assignee thereunder, the Mortgagee may pay the premiums for such insurance and add said payments to the principal indebtedness secured by this mortgage to be repaid in the same manner and without changing the amount of the monthly payments, unless such change is by mutual consent.
