VILLAGE OF CRESTWOOD

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN REAL ESTATE TO THE VILLAGE OF CRESTWOOD,

COOK COUNTY, ILLINOIS

COMMONLY KNOWN AS: 4933 WEST 142ND STREET PROPERTY OWNER: STEWART R. ROY

WHEREAS, there has been previously filed with the Village Clerk a Petition requesting annexation of the real estate described below to the Village of Crestwood, Cook County, Illinois; and
