MEMORANDUM OF INSTALLMENT PURCHASE AGREEMENT

Pln U5-20-319-418, Address. 110 Evergreen Lane, Winnetka, Illinois (the "Property").
- 2. Under the Contract, the Purchaser must pay to ADTA Corporation or its order the sum of \$375,000 less prorations plus interest as stated in the Contract on or before September 50, 1994 and otherwise comply with the terms of the Contract
