

CERTIFICATE OF COMPLETION

Pursuant to Section 4.10 of that certain "Redevelopment Agreement, New Homes for Chicago Program, Voice of the People in Uptown, Inc.," dated July 23, 1993, by and between the City of Chicago, an Illinois municipal corporation ("City"), and located at 121 North LaSalle Street, and Voice of the People in Uptown, Inc., ("Developer"), located at 4753 North Broadway Avenue, Suite 1010, Chicago, Illinois, the Department of Housing on behalf of the City, hereby certifies that Developer has substantially completed the construction of the single family housing unit improving the real property described below ("Property") in accordance with the provisions contained in the Redevelopment Agreement, and the objectives of the New Homes for Chicago Program of the City of Chicago.

This certificate is conditional upon installation of Kitchen Range and Refrigerator, and the completion of Architect's punch list. This shall remain the responsibility of the Contractor and Developer to complete.

LEGAL DESCRIPTION:

OF LOT 26 IN BLOCK 7 OF ARGYLE, BEING A SUBDIVISION OF LOTS 1 AND 2 OF FUSSEY AND FENNIMORE'S SUBDIVISION OF THE SOUTHWEST FRACTIONAL QUARTER OF SECTION 8, TOWNSHIP 40 NORTH, RANGE 14, EAST OF THE THIRD PRINCIPAL MERIDIAN, AND LOTS 1 AND 2 OF COLEHOUR AND CONARROE'S SUBDIVISION OF LOT 3 OF SAID FUSSEY AND FENNIMORE'S SUBDIVISION, IN COOK COUNTY, ILLINOIS.

PARCEL P-51 THE SOUTH 8 FT OF THE NORTH 40 FT OF THE WEST 24 FT OF LOT 26 IN BLOCK 7 OF ARGYLE, BEING A SUBDIVISION OF LOTS 1 AND 2 OF FUSSEY AND FENNIMORE'S SUBDIVISION OF THE SOUTHWEST FRACTIONAL QUARTER OF SECTION 8, TOWNSHIP 40 NORTH, RANGE 14, EAST OF THE THIRD PRINCIPAL MERIDIAN, AND LOTS 1 AND 2 OF COLEHOUR AND CONARROE'S SUBDIVISION OF LOT 3 OF SAID FUSSEY AND FENNIMORE'S SUBDIVISION, IN COOK COUNTY, ILLINOIS.

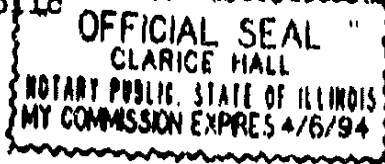
