AN ORDINANCE

Dedicating for Street Purposes
Certain Privately-Owned Land on Park Place
Northwest of Gross Point Road

WHEREAS, the owners of certain land on Park Place Northwest of Gross Point Road are desirous of dedicating same to the City for street purposes, and

WHEREAS, said dedication will be made at no cost to the City, and

WHEREAS, it is in the best interest of the City to accept said dedication and pave the land for use as a City street,

NOW, THEREFORE, BE IT OBTAINED BY THE CITY COUNCIL OF THE CITY OF EVANSTON, COOK COUNTY, ILLINOIS:

SECTION 1: That the rectangular portion of property, sixty feet in width and three hundred twenty feet in length, being the westerly extension of Park Place as heretofore dedicated, and lying northwest of Gross Point Road, and legally described as follows:

"THE SOUTH 30 FEET OF LOTS 6, 7, 8, AND 9 AND THE NORTH 30 FEET OF LOTS 2, 3, 4, AND 5 IN NILLE'S SUBDIVISION, IN SECTION 33, TOWNSHIP 42 NORTH, RANGE 13, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS."

as set forth in a plat of dedication dated June 14, 1991, by Illinois Land Surveyor No. 2542, Raymond R. Hansen, attached to, and incorporated into, this Ordinance, be and hereby is accepted
