**AN ORDINANCE  
ANNEXING CERTAIN TERRITORY TO THE VILLAGE OF PALATINE  
788 W. HELLEN ROAD**

WHEREAS, the Owners of record of the following described territory have petitioned that said territory be annexed to the Village of Palatine, Illinois; and

WHEREAS, the Municipal Authorities find and have determined that said territory is contiguous to the Village of Palatine; and

WHEREAS, the Palatine Rural Fire Protection District has been duly notified in writing more than ten (10) days in advance of consideration of this ordinance, pursuant to statutes;

NOW, THEREFORE, BE IT ORDAINED, by the President and Board of Trustees of the Village of Palatine, acting in the exercise of their home rule power:

**SECTION 1:** That the following territory:

Lots 17 and 18 in Block 5 in Arthur T. McIntosh and Company's North West Acres Unit No. 2, a subdivision in the South Half of the North West Quarter of Section 22, Township 42 North, Range 10, East of the Third Principal Meridian, in Cook County, Illinois

And also that portion of the unincorporated right of way of Hellen Road and Quentin Road adjacent to the above described properties.

Commonly known 788 W. Hellen Road

and as shown on the plat of annexation attached hereto and made a part of this ordinance, be and the same is hereby annexed to the Village of Palatine.

**SECTION 2:** That upon passage of this ordinance, a copy hereof, including the plat as certified as correct by the Village Clerk, be filed with the Recorder of Deeds of Cook County, Illinois in accordance with 65 ILCS 5/7-1-1 et. seq.
