SECURITY INSTRUMENT RIDER

PARCH TRIDGIS

This Rider, attached to and made part of the Mortgage, Mortgage Deed, Deed of Trust, Security Deed or Vendor's Lien (the "Security Instrument") between RANDALL JEPSEN and GWENDOLYN JEPSEN (the "Borrower") and FLEET MORTGAGE CORP. (the "Lender") dated APRIL 12, 1994, revises the Security Instrument as follows:

- . 1. <u>Due-On-Sale</u>: This loan may be declared immediately due and payable upon transfer of the property securing such loan to any transferce, unless the acceptability of the assumption of the loan is established pursuant to section 1814 of Chapter 37, title 38, United States Code.
- 2. If the assumer fails to pay this fee at the time of transfer, the fee shall constitute an politional debt to that already secured by this instrument, shall bear interest at the rate herein provided, and, at the option of the payee of the indebtedness hereby secured or any transferee thereof, shall be immediately due and payable. This fee is automatically waived if the assumer is exempt under the provisions of 38 U.S.C. 1829 (b).
- 3. Processing Charge: Upon application for approval to allow assumption of this loan, a processing fee may be charged by the loan holder or its authorized agent for determining the creditworthiness of the assumer and subsequently revising the Lolder's ownership records when an approved transfer is completed. The amount of this charge shall not exceed the maximum established by the Veteran's Administration for a loan to which section 1814 of chapter 37, title 33. United States Code applies.
- 4. <u>Indemnity Liability</u>: If this obligation is assumed, then the assumer thereby agrees to assume all of the obligations of the veteran under the terms of the instruments creating and securing the loan, including the obligation of the veteran to indemnify the Veterans Administration to the extent of any claim payment arising from the guaranty or insurance of the indebtedness created of the instrument.
- 5. The borrower further agrees that should this Security Instrument and the note secured hereby not be eligible for guarantee under the Servicemen's Readjustment Act of 1947 as amended within 90 days from the date hereof (written statement of any officer of the Veterans Administration or authorized agent of the Secretary of Veterans Affairs dated subsequent to the 90 days time from in a que of this security instrument, declining to guarantee said note and this mortgage, being deemed conclusive record of such ineligibility), the Lender or the Holder of the note may at its option declare all sums secured vereoy immediately due and payable.
