THIS MORTGAGE (Mongage") is given this April 18, 1994.
The mortgager(s) are Tino Chiakas, and Margaret L. Chiakas, his wife in joint tenancy, (collectively, the "Borrower").

This mongage is given to BAXTER CREDIT UNION, on Illinois Banking Corporation, whose address is 1425 Lake Cook Road, Deerlield, Illinois 80015 ("Lender"). The Borrower owes the Lender the maximum principal sum of:

Seventy Thousand and 00/100 -- Dollars (\$70,000.00), or the aggregate unpaid amount of all loans made by the Lander pursuant to that certain Line of Credit Agreement ("Agreement") and Line of Credit Adjustable Rate Note ("Note") between the Borrower and the Lander of even date herewith, the terms of which are incorporated herein by reference. The Agreement establishes a revolving line of credit pursuant to Section 5c of the Illinois Banking Act, Ill.Rev.Stat.Ch, 17, Sec. 312.3. The Note provides for

monthly interest payments, with the full debt, if not paid earlier, due and payable on demand by after 5 years from the date of the Mortgage. Interest shall accrue on these amounts at the rate(s) set forth in the Note. The Agreement provides that foans may be made from time to time (but in no event later than 5 years from the date hereof) not to exceed the maximum credit limit assigned to Borrower by Lander from time to time. All future loans, whether obligatory or optional, shall be secured to the same extent and with the same priority as if made on the date hereof.

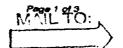

- 1. Payment of Principal and Interest. The Borrower shall promptly pay when due the principal of and interest on the debt evidenced by the Note and all other amounts owing under the Note, including principal and interest on any Future Advance procured by the Mortgage.
- 2. Payment of Taxes, insurance and Other Charges. - 10. Successors and Assigns. The covenants and agreements of this Mortgage shall bind and benefit the successors and assigns of Lender and Borrower, subject to the provisions of Paragraph 5 hereof, Borrowers covenants and agreements shall be joint and several. Any person who co-signs this Mortgage but dous not execute the Note, (i) is co-signing this Mortgage under the terms of this Mortgage, (ii) is not personally obligated to pay the sums secured by this Mortgage, and (iii) agrees that Lander and any other Borrower may agreed to extend, modify, forebear or make any accommodations with regard to the terms of this Mortgage or the Note without that Borrowers consent.
- 11. Loan Charges, if the interest or other loan charges collected or to be collected in connection with the loans made under the Agreement or the Note exceed permitted limits as finally interpreted by a court of competent jurisdiction, any sums already collected from Botrower which exceeded permitted limits will be retunded to Borrower. Lander may choose to make this retund by reducing the principal owed under the Note or by making a direct payment to Borrower. If a refund reduces principal, the reduction will be treated as a partial prepayment without any prepayment charge.
- 12. Legislation Affecting on ter's Rights. If the enactment or expiration of applicable laws has the effect of rendering any provision of the Agreement, the Note, or this Mortgage unemucosuble according to its terms, Lander, at its uption, upon ninety (90) days prior notice to Sorrower may require immediate payment in full of all sums secured by this Mortgage and may include any remediate permitted by Paragraph 17 hereof.
- 13. Musices. Any notice to Borrov er provided for in this Mortgage shall be given by delivering it or by mailing it by registered or dertified mail unless applicable law requires use of another method. The notice shall be directed to the Property Address or any other address Borrower designates by written notice to Landar, chall be given by registered or destined mail to the Lunder's address stated herein, or any other address Lender designates by written notice to Borrower. Any notice provided for in this Mortgage shall be deemed to have been given to Borrower or Lender when given as provided in this Paragraph.
- 14. Governing Law, This Mortgage shall be governed by the laws of the State of Illinois. In the event that any provision or clause of this Mortgage conflicts with applicable law, such conflict shall not affect oner provisions of this Mortgage. To this end the provisions of this Mortgage are declared to be severable.
- 15. Due on Sale. These dates shall be known as "Change Detec ' (C) INDEX Changes in the interest rate shall be based upon changes in the "Index." The Index shall be the highest domestic Prime Rate as reported in the Money Ra Section of the Midwest Edition of The Wall Street Journal on the last business day of the month immediately preceding the beginning of each billing period. If the Wall Street Journal stops reporting the Prime Rate, or if the Prime Rate is not available on the said last business day, then Lender will choose a comparable index as a substitute for the Prime Rate and will notify the Borrower of such change.

The Agreement has an "Initial Index" figure of 6,250%.

(D) CALCULATION OF CHANGES

Prior to each Change Date, Lender shall determine any change in the interest rate, and shall calculate the new interest rate by adding 0.500% to the Current Index. Lander will round the result of this addition to the nearest one—eighth of one percentage point (0.125%). This rounded amount will be the new great rate until the next Change Date. If the new interest rate increases or decreases, the monthly payment may also increase or decrease.

(E) EFFECTIVE DATE CHANGES

The new interest rate will become effective on each Change Date and Borrower will pay the amount of the new monthly payment beginning on the Change Date until the amount of the monthly payment changes again.

(F) DISCLOSURES

Lender will send statements at least quarterly reflecting changes in the interest rate and payments during the quarterly period. The disclosure shall reflect the change of the interest rate, heavy and the amount of the new payment, and other transactions in the account during the period. Buch statement shall be presumed correct unless do wer notifies Lender in writing of any error within strty (60) days after the closing date of the billing period.
