

NOTE

Note 1:

If the corporate name which ther corporation had at the time of dissolution or revocation is not available for use at the time of reinstatement, the corporation shall set forth the new name by which it will hereafter be known. A change of corporate name must also be properly effected in accordance with the provisions of the General Not For Profit Corporation Act of 1986. For domestic corporations, Articles of Amendment must be filed, rursuant to Section 110.30. For foreign corporations, the name must be changed in the state or country of incorporation by articles of amendment filed there, and an Application for Amended Certificate of Authority, together with a certified copy of the amendment, must be filed pursuant to Section 113.40.

Note 2:

If a foreign corporation's true name was not available for use when the original certificate of authority was issued and is still not available, the corporation had to adopt an assumed corporate name for use in Illinois. When reinstating, an Application For An Assumed Corporation Name, rurs and to Section 104.15, must accompany the reinstalement application.

Note 3:

If either or both the registereri agent or the registered office of the corporation has changed since the time of dissolution or revocation, the corporation shall properly report 20 o. such a change on form NP-105.10/165 20 or on its most recent annual report form.
