THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 1 (THE REVERSE SIDE OF THIS TRUST DEED):

1. Mortgagors shall (a) promptly repair, restore or robuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (b) keep said premises in good condition and repair, without waste, and tree from mechanic's or other liens or claims for iten not expressly subordinated to the lien hereot; (c) pay when due any indebtedness which may be socured by a lien or charge on the premises superior to the lien hereot, and upon request exhibit satisfactory avidence of the discharge of such prior lien to Trustee or to Holders of the Note; (d) complete within a reasonable time any buildings now or at any time in process of erection upon said premises; (e) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereot; (f) make no material alterations in said premises except as required by law or municipal ordinance.

2. Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall, upon written request, furnish to Trustee or to Holders of the Note duplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors may desire to contest.

2. Mortgagore shall pay before any penalty attaches all general taxes, and shall pay special taxes, special spassaments, water charges, sever service charges, and other charges against the premises when due, and shall, upon written request, furnish to Tratistee or the cupicate and control of the control o

Trustee has no duty to examine the title, location, existence or condition of the premises, or o inquire into the validity of the signatures or the identity, capacity, or authority of the signatures on the note or but deed, nor shall Trustee be obligated to rec vid this rust deed or to exercise any power herein given unless expressly obligated by the terms hereof, nor be liable for any acts or omissions hereunder, except in cast of its own gross negligence or misconduct or that of the agents or employees of Trustee, and it may require Indemnities satisfactory to it before exercising any prove herein given.

13.
