TAXES - LIENS - INSULAR vi i pay when hey a obligations, water rates and any other charges against the Property, whether superior or inferior to the lien of this morigage, maintain hazard insurance on the Property in your favor in a form and amount satisfactory to you and maintain and keep the Property in good repair at all times during the term of this mortgage. You may file proof of loss if not made promptly by me.
