Courtland Square Condominium Building No. 33 Association, an Illinois not-for-profit corporation, hereby files a Claim for Lien against Ronald A. Beretta and Janis B. Beretta of Cook County, Illinois, and states as follows:

As of the date hereof, the said debtors were the owners of the following land, to wit:

Unit No. 107G, as delineated on the survey of the following described real estate (hereinafter referred to as "Parcel"): That part of the Southeast quarter of Fractional Section 10, Township 41 North, Range 12 East of the Third Principal Meridian, described as follows: Commencing at the Southeast corner of the aforesaid Southeast Quarter of Section 10; thence North 15.92 feet along the East line of said Southeast quarter; thence West 838.11 feet along a line drawn perpendicular to the East line of said Southeast quarter, to the point of beginning of the herein described tract of land; thence continuing West 73.50 feet along the Westerly extension of said perpendicular line; thence North 185.05 feet along a line drawn parallel with the East line of the aforesaid Southeast quarter; thence East 73.50 feet along a line drawn perpendicular to the East line of the aforesaid Southeast quarter; thence South 185.05 feet along a line drawn parallel with the East line of the aforesaid Southeast quarter, to the hereinabove designed point of beginning, in Cook County, Illinois, which survey is attached as Exhibit "B" to Declaration of Condominium Ownership and of Easements, Restrictions and Covenants for Courtland Square Condominium Building No. 33 made by Harris Trust and Savings Bank, as Trustee under Trust Agreement dated February 28, 1979 and known as Trust No. 39321, and recorded in the Office of the Cook County Recorder of Deeds as Document No. 25053465, together with an undivided 7.474227% interest in said Parcel (excepting from said Parcel all the units thereof as defined and set forth in said Declaration of Condominium Ownership and survey)

and commonly known as 8884 Steven Drive, Unit 107G, Des Plaines, Illinois 94382597

That said property is subject to a Declaration of Condominium recorded in the office of the Recorder of Deeds of Cook County, Illinois as Document No. 25053465. 


In the sum of \$881.84, which sum will increase with the levy of future assessments, costs and fees of collection, all of which must be satisfied prior to any release of this lien.



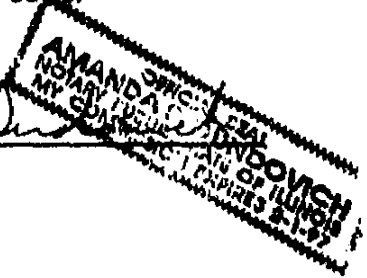
