

Member authorization may also be by vote at a membership meeting or by less than unanimous consent, in writing, without a meeting

To be effective, the dissolution must receive the alternative vote or consent of at least 2.3s of the members entitled to vote on dissolution, and, if class voting applies, then also at least 2/3s of the votes within each class

If the Articles of Incorporation so provide, the 2/3s vote requirement may be superseded by any smaller or larger vote requirement not less than a majority of the members entitled to vote and not less than a majority within each class when class voting applies

When member authorization is by less than unanimous written consent, all members must be given notice of the proposed dissolution ia is beh. Sylhorize. action at least five days before the consent is signed. Members who have not signed the consent must be given prompt notice that dissolution was drivia athorized.
