- (C)Borrower's Promises. You promise to.
 - (1)Pay all amounts when due under your Agreement, including interest, and to perform all duties of the loan agreement and/or this Mortgage.
 - (2)Pay all taxes, assessments and liens that are assessed against the Property when they are due. It you do not pay the taxes, assessments or liens, we can pay them, if we choose, and add what we have paid to the amount you owe us under your Agreement with interest to be paid as provided in that Agreement.
 - (3) Not execute any mortgage, security agreement, assignment of leases and rentals or other agreement granting a lien against your interest in the property without our prior written consent, and then only when the document granting that hen expressly provides that it shall be subject to the field of this Mortgage.
 - (4) Keep the Property in good repair and not damage, destroy or substantially change the Property.
 - (5) Keep the Property insured against loss or damage caused by fire or other hazards as left an insurance carrier acceptable to us. The insurance policy must be payable to us and name us as Insured Morgages for the amount of your loan. You must deliver a copy of the policy to us if we request it. It you do not obtain insurance, or pay the premiums, we may do so and add what we have paid to the amount you owe us under your Agreement with increst to be paid as provided in the loan agreement. At our option, the insurance proceeds may be applied to the balance of the loan, whether or not due, or to the rebuilding of the Property
 - (6)Keep the Property covered by flood insurance if it is located in a specially designated flood hazard zone.
- (DiEnvironmental Condition. You shall not cause or permit the presence, use, disposal or release of any hazardous substances on or in the Property. You shall not do, nor allow anyone else to do, anything affecting the Property that is in violation of any environmental law. You shall promptly give us written notice of any investigation, claim, demand, lawsuit or other action by any governmental or regulatory agency or private party involving the Property or release of any hazardous substance on the Property B you are notified by any governmental or regulatory authority that any removal or other remediation of any hazardous substance affecting the Property is necessary, you shall promptly take all necessary remedial actions in accordance with applicable environmental laws.

- E) Default. If you do not keep the promises you made in this Mortgage or you tail to meet the terms of your Agreement, you will be in default. If you are in default, we may use any of the rights or remedies stated in your Agreement including, but not limited to, those stated in the Default, Remedies on Default, and/or Reducing the Credit Limit paragraphs or as otherwise provided by applicable law. If we accelerate your outstanding balance and demand payment in tifl, you give us the power and authority to self the property according to procedures allowed by faw. The proceeds of any sale will be applied first to any costs and expenses of the sale, including the costs of any environmental investigation or temediation paid for by us, then to reasonable attorney's fees and then to the amount you owe us under your Agreement.

- (1) Other Terms. We do not give up any of our rights by delaying or failing to exercise them at any time. Our rights under the Agreement and this Mortgage are cumulative. You will allow us to inspect the Property on reasonable notice. This shall include the right to perform any environmental in estigation that we deem necessary and to perform any em it inmental remediation required under environmental law for investigation or remediation will be conducted solely for our benefit and to protect our interests. If any term of this Micreage is found to be illegal or menforceable, the other terms will still be in effect. This Agreement may secure "revolving credit" as defined in 815 ILCS 205/4.1. The revolving credit line shall be governed by and construed in accordance with the Illinois Financial Services Development Act, 175 IECS 675/1, et seg.
