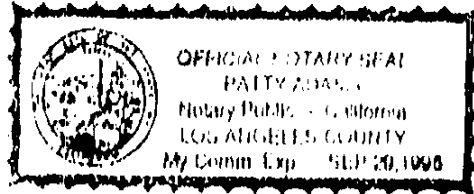

✓ PARCEL 1:

That part of Lot 7 in Block 5 in Streamwood Green Unit 5 being a subdivision of part of the East Half of the North West Quarter of Section 24, Township 41 North, Range 9, East of the Third Principal Meridian, described as follows: Commencing at the North East Corner of said Lot 7; Thence North 89 degrees 30 minutes 29 seconds West, along the North Line of said Lot 7, a distance of 58.8 feet to a point of Curvature; thence South 7 degrees 55 Minutes, 12 Seconds East, A distance of 61.14 feet to the point of beginning, thence South 82 degrees 4 minutes 48 seconds west at right angles to last described course, a distance of 50.16 feet to a point on the westerly line of said Lot 7, thence South 17 degrees 51 minutes 00 seconds East along said Westerly Line a distance of 65.64 feet to the South West Corner of said Lot 7, thence North 86 degrees 38 minutes, 3 seconds East, A distance of 38.96 feet to the intersection with a line, having a bearing of South 7 degrees 55 minutes an seconds East, drawn from the point of beginning, thence North 7 degrees, 55 minutes 12 seconds West along said line, a distance of 67.75 feet to the point of beginning in Cook County, Illinois.
