ARTICLES OF ACREMENT FOR DEED & Mortiner.

1.BUYER, James Stagen Address 3151 W. Wellington, Chicago; Cook County; State of Illinois agrees to purchase, and SELLER, Valentine Martinez and Maria Khis wife, 4433 W. Deming Place, Chicago, Illinois agrees to sell to Buyer at the PURCHASE PRICE of One Hundred Sixty Two Thousana Five Hundred Dollars (\$162,500.00) the PROPERTY commonly known as 3058 W. Belmont, Chicago, Illinois and legally described as follows:

LOT 28 AND THE WESTERLY 1 FOOT OF LOT 27 IN BLOCK 8 IN S.E. GROSS UNTER DEN LINDEN ADDITION TO CHICAGO, BEING PART OF THE SOUTH 18.787 CHAINS OF THE SOUTH 1/2 SECTION 24, TOWNSHIP 40 NORTH, RANGE 13, EAST OF THE THIRD PRINCIPAL, LYING WEST OF THE CENTER OF ELSTON ROAD AS PLATTED AND RECORDED MAY 18, 1388 AS DOCUMENT NO. 959047, IN COOK COUNTY, ILLINOIS.

(hereinafter referred to as "the premises")

with approximate lot dimensions as per survey, together with all improvements and fixtures, if any, including, but not limited to: All central heating, plumbing and electrical systems and equipment; the hot water heater; central cooling, humidifying and filtering equipment; fixed carpeting; built-in kitchen appliances, equipment and cabinets; water softener (except rental units); existing storm and screen windows and doors; attached shutters, shelving, fireplace screen; roof or attic T.V. antenna; all planted vegetation; garage door openers and car units; all being conveyed in AS IS CONDITION.

All of the foregoing items shall be left on the premises, are included in the sale price, and shall be transferred to the Buyer by a Bill of Sale at the time of final closing.

#### 2. THE DEED:

a. If the Buyer shall first make all the payments and perform all the covenants and agreements in this agreement required to be made and performed by said Buyer, at the time and in the manner





hereinafter set forth, Seller shall convey or cause to be conveyed to Buyer (in joint tenancy) or his nominee, by a recordable, stamped general warranty deed with release of homestead rights, good title to the premises subject only to the following "permitted exceptions, "if any: (a) General real estate taxes not yet due and payable; (b) Special assessments confirmed after this contract date; (c) Building, building line and use of occupancy restrictions, conditions and covenants of record; (d) Zoning laws and ordinances; (e) Easements for public utilities; (f) Drainage ditches, feeders, laterals and drain tile, pipe or other conduit; (g) If the property is other than a detached, single-family home: party walls, party wall rights agreements; covenants, conditions and restrictions of record.

- b. The performance of all the covenants and conditions herein to be performed by Buyer shall be a condition precedent to Seller's obligation to deliver the deed aforesaid.
- 3.INSTALLMENT PURCHASE. Buyer hereby covenants and agrees to pay to Seller at 4433 W. Deming Flace. Chicago. Illinois or to such other person or at such other place as Seller may from time to time designate in writing, the purchase price and interest on the balance of the purchase price remaining from time to time unpaid from the date of initial closing at

the rate of <u>Nine and Three Quarters</u> percent (9.75%) per annum, all payable in the manner following to wit:

- (a) Buyer has paid \$ Five Thousand Obllars (\$5,000.00) as earnest money to be applied on the purchase price. The earnest money shall be held by Century 21-Orion for the mutual benefit of the parties concerned;
- (b) At the time of the initial closing, the idditional sum of \$ 15,000.00, plus or minus provations, if any, as is hereinafter provided;
- (c) The balance of the purchase price, to wit: \$ 142,500.00 to be paid in equal monthly installments of \$ 1,269.50 each, commencing on the 1st day of July, 1995, and on the 1st day of each month thereafter until the purchase price is paid in full ("Installment payments");
- (d) The final payment of the purchase price and all accrued but unpaid interest and other charges as hereinafter provided, if not sooner paid shall be due on the <u>lst</u> day of <u>June</u>, <u>2000</u>;
- (e) All payments received hereunder shall be applied in the following order of priority: first, to interest accrued and owing on the unpaid principal balance of the purchase price; second, to pay before delinquent all taxes and assessments which subsequent to the date of this Agreement may become a lien on the premises; third, and to pay insurance premiums falling due after the date of this Agreement; and fourth, to reduce said unpaid principal balance of the purchase price;



- (f) Payments of principal and interest to Seller shall be received not in tenancy in common, but in joint tenancy with the right of survivorship.

- 4. CLOSING: The "initial closing" shall occur on or about May 31, 1995, (or or the date, if any, to which said date is extended by reason of subparagraph 8 (b) at to be agreed. "Final closing" shall occur if and when all covenants and conditions herein to be performed by Buyer have been so performed.
- 5. POSSESSION: Possession shall be granted to Buyer at 12:01 A.M. on date of closing, provided that the full down payment minus net prorations due in favor of Buyer, if any, has been paid to Seller in cash or buy cashier's or certified check on the initial closing date, and further provided that Buyer on such initial closing date is otherwise not in default horeunder. Seller will cause the third floor to be vacant at closing.

#### 6. PRIOR MORTGAGES:

- (a) Seller reserves the right to keep or place a mortgage or trust deed ("prior mortgage") against the title to the premises with a balance including interest not to exceed the balance of the purchase price unpaid at any time under this Agreement, the lien of which prior mortgage shall, at all times notwithstanding that this Agreement is recorded, be prior to the interest that Buyer may have in the premises, and Buyer expressly agrees upon demend to execute and acknowledge together with Seller any such more gage or trust deed (but inot the inotes) secured thereby). No mortgage or trust deed placed on said premises including any such prior wortgage. shall in any way accelerate the time of payment provided for in the Agreement or provide for payment of any amount, either interest or principal, exceeding that provided for under this Agreement, or otherwise be win a conflict with the terms and provisions of the Agreement, a nor a shall a such a mortgage oor trust deed ain any way restrict the right of prepayment, if any, given to Buyer under this Agreement.
- (b) Seller shall from time to time, but not less frequently than once each year and anytime Buyer has reason to believe a default may exist, exhibit to Buyer receipts for payments made to the holders of any indebtodness secured by any such prior mortgage.
- (c) In the event Seller shall fail to make any payment on the indebtedness secured by a prior mortgage or shall suffer or permit there to be any other breach or default in the terms of any indebtedness or prior mortgage, Buyer shall have the right, buy not



the obligation, to make such payments or cure such default and to offset the amount so paid or expended including all incidental costs, expenses and attorney's fees attendant thereto incurred by Buyer to protect Buyer's interests hereunder from the unpaid balance price or from the installment payments to be made under this Agreement.

7. SURVEY: Prior to the initial closing, Seller shall deliver to Buyer or his agent a spotted survey of the premises, certified by a licensed surveyor, having all corners stated and showing all improvements existing as of this contract date and all easements and building lines.

#### 8. TITLE:

- At least one (1) business day prior to the initial closing, Seller shall furnish or cause to be furnished to Buyer at Seller's expense an Owner's Duplicate Certificate of Title issued by the Registrar of Titles and a Special Tax and Lien Search or a commitment dissued by a title insurance company licensed to do business in allinois, to issue a contract purchaser's title insurance policy on the current form of American Land Title Association Owner's Policy (or equivalent policy) in the amount of the purchase price covering the date hereof, subject only to: (1) the general exceptions contained in the policy unless the real estate is improved with a single family dwelling or an apartment building of four or fewer residential units; (2) the "permitted exceptions" set \* forth : in -paragraph in paragraph 2; (3) prior mortgages permitted in paragraph 6; (c) other title exceptions pertaining to liens or encumbrances of a definite or ascertainable amount, which may be removed by the payment of money and which shall be removed at or prior to the initial closing and (5) acts done gor suffered by or judgments against the Buyer, or those claiming by, through or under the Buyer.

- (c) Every title commitment which conforms with subparagraph "a" shall be conclusive evidence of good title therein shown, as to all matter insured by the policy, subject only to special exceptions therein stated.
- (d) If a Special Tax Search, Lien Search, a judgment Search or the title commitment disclose judgments against the Buyer which may become liens, the Seller may declare this Agreement null and void and all earnest money shall be forfeited by the Buyer."

- (e) Buyer's taking possession of the premises shall be conclusive evidence that Buyer in all respects accepts and is satisfied with the physical condition of the premises, all matters shown on the survey and the condition of title to the premises as shown to him on or before the initial closing. - 10. PRODATIONS: Insurance premiums, general taxes, association assessments and, if final meter readings cannot be obtained, water and other utilities shall be adjusted ratably as of the date of initial closing. Real estate taxes for the year of possession shall be prorated as of the date of initial closing subject to reproration upon receipt of the actual tax bill. Further, interest on the unpaid principal amount of the purchase price from the initial closing date until the date of the first installment payment shall be a proration credit in favor of the Seller.

#### 19. PERFORMANCE:


