THIS AGREEMENT made as of this 26th day of June, 1995, by and between
Village of Maywood ("Lienholder") and TCF Consumer Financial Services, Inc.

NOW THEREFORE, for good and valuable consideration, and in order to induce TCF Consumer Financial Services, Inc. to advance funds upon its mortgage, Lienholder does hereby subordinate the lien of its mortgage to the lien of TCF Consumer Financial Services, Inc. mortgage, and all extensions, modifications and renewals thereof and all advances and future advances thereunder, notwithstanding that the Lienholder's mortgage was executed and recorded prior to the execution and recordation of TCF Consumer Financial Services, Inc. mortgage, and agrees that all right, title, lien and interest acquired by TCF Consumer Financial Services, Inc. either by foreclosure proceedings or otherwise, under its mortgage, shall be prior and superior to any and all rights, title, lien and interest heretofore or hereafter acquired by Lienholder under the Lienholder's mortgage.
