### FUST MODIFICATION OF MORTGAGE AND ASSIGNMENT OF RENTS AND LEASES

THIS FIRST MODIFICATION OF MORTGAGE AND AGSIGNMENT OF RENTS AND LEASES (this "Agreement") dated as of May 1, 1995 is between LASALLE NATIONAL BANK, a national banking association ("Mortgagee") and LATINO YOUTH, INC., an Illinois not-for-profit corporation ("Mortgagor").

### RECITALS:

- A. Mortgagor executed a Mortgage, Security Agreement and Financing Statement (the "Mortgage") dated as of May 10, 1993 and recorded on May 13, , 1993 as Document No. 93-361778 in the Office of the Cook County Recorder of Deeds (the "Recorder's Office") and encumbering certain property common's known as 2200 South Marshall Boulevard, Chicago, Illinois 60623, and as more particularly described in Exhibit A attached hereto (the "Premises");
- f. Mortgagor executed an Assignment of Rents and Leases (the "Assignment") dated as of May 10, 1993 and recorded on May 13, , 1993 as Document No. 93-361779 in the Recorder's Office and relating to the Premises;
- C. The Mortgage and Assignment secure (i) that certain \$100,000 Note dated as of May 10, 1993 (the "Term Note"), and (ii) that certain \$125,000 Revolving Note dated as of May 10, 1993 (the "Revolving Note" and, together with the Term Note, the "Note;"), and any and all renewals, extensions and modifications of either thereof;
- D. The Term Note bears interest prior to maturity or the occurrence of a Default at a rate equal to 8.69% per annum and

the Revolving Note has heretofore bourn interest at a rate equal to 6.15% per annum;

- Mortgagor has, contemporaneously herewith, accepted from Mortgagee a \$125,000 Replacement Revolving Note dated as of May 1, 1995 in substitution for the Revolving Note, which bears interest at a rate equal to 8-3/4% per annum;
- Mortgagor and Mortgagee desire that from and after the date hereof, all references to the Revolving Note in the Mortgage and in the Assignment shall be deemed to be references to the Replacement Revolving Note as aforesaid;

NOW, THEREFORE, in consideration of the foregoing, the parties hereby agree as follows:

- Note Secured. (a) The term "Revolving Note", as defined in each of the Mortgage and Assignment, is hereby amended to be the Replacement Revolving Note as defined herein.
- (b) Mortgagor exprastly agrees that the Mortgage and Assignment secure the Notes, any and all extensions, renewals and modifications thereof and substitutions therefor, and any other sums, liabilities or indebtedness as set forth in the Mortgage or the Assignment.
- 2. <u>Continuing Effect</u>. All the terms of the Mortgage and Assignment are hereby incorporated by reference herein, and the Mostgage and Assignment, except as hereby modified, shall remain in full force and effect in all respects. Mortgagor, by execution of this Agreement, hereby reaffirms, assumes and binds itself to all of the obligations, duties, rights, covenants, terms and conditions that are contained in the Mortgage and Assignment.
