Guarantor. The word "Guarantor" means and includes without limitation each and all of the guarantors, sureties, and accommodation parties in connection with the indebtedness.

Indebtedness. PROPERTY DAMAGE INSURANCE. The following provisions relating to insuring the Property are a part of this Mortgago.

Maintenance of Insurance.
