The Lender or anyone who takes the Note, the Security Instrument and this Rider by transfer and who is entitled to receive payments under the Note is called the "Note Holder."

ADDITIONAL COVENANTS. In addition to the covenants and agreements in the Security Instrument, Borrower and Lender further covenant and agree as follows (despite anything to the contrary contained in the Security Instrument or the Note):

#### 2. CONDITIONS TO CITTON

If I want to exercise the Conditional Refinancing Option at maturity, certain conditions must be met as of the Maturity trate. These conditions are: (!)
