TAXES - LIENS - INSURANCE : MAINTENANCE - I will pay, when they are due and payable, all laxes, Henr, assessments, obligations, water rates and any other charges against the Property, whether superior or inferior to the lien of this mortgage, maintain hazard insurance on the Property in your favor in a form and amount satisfactory to you and maintain and keep the Property in good repair at all times during the term of this mortgage.
