21725! MODIFICATION AGREEMENT REI TITLE SERVICES # B7-605

This Modification Agreement (this "Agreement") is entered into as of the lat day of May, 1995 by and among COLUMBIA NATIONAL BANK OF CHICAGO not personally, but solely as Trustee under Trust Agreement dated February 15, 1994 and known as Trust Number 4574 ("Mortgagor") and COLUMBIA NATIONAL BANK OF CHICAGO ("Mortgagee").

WHEREAS, Mortgagor executed a certain Mortgage and Security Agreement dated April 1, 1994 (the "Mortgage"), mortgaging, granting, and conveying to Mortgagee the real estate situated in the County of Cook, Brate of Illinois, described in Exhibit A attached hereto, to secure the following described loans: (1) a \$250,000.00 revolving line of credit loan extended by Mortgagee to Midland Foods, Inc. (the "Rivolving Loan"), evidenced by Midland Food, Inc.'s Revolving Credit Note dated April 1, 1994 in the principal sum of \$250,000.00 payable to the order of Mortgagee on May 1, 1995, together with interest payable monthly as therein recited (the "First Note"), and (2) an \$850,000.00 mortgage loan (the "Mortgage Loan") made by Mortgages to the Mortgagor evidenced by the Mortgagor's Mortgage Note dated April 1, 1994 in the principal sum of \$850,000.00 payable to the order of Mortgagee in installments as therein recited (the "Secord Note"); and

WHEREAS, the Mortgage was recorded on May 5, 1994, in the office of the Recorder of Deeds of Cook County, Illinois as Document No. 94406049; and

WHEREAS, Midland Foods, Inc. has requested that Moregages extend the Revolving Loan and convert it to a term loan; and

WHEREAS, Mortgages has agreed to such extension and conversion, on condition that Mortgagor executes and delivers this Agreement to Mortgagee, and such other documents and instruments required Mortgagee;

NOW THEREFORE, in consideration of the premises and for good and valuable consideration, Mortgagor and Mortgagee hereby agree that the Mortgage shall be and is hereby modified and amended as follows:

- The capitalized terms used herein without definition shall have the same meaning herein as such terms have in the Mortgage.
- 2. In the first "WHEREAS" clause on page 1 of the Mortgage, subsection (ii) thereof, is amended in its entirety to read as follows: "(ii) term note dated May 1, 1995 in the principal amount of Two Hundred Fifty Thousand and 00/100 (\$250,000.00) Dollars payable in installments of principal and interest as therein racited (bearing interest at the variable rate specified therein), made by Midland Foods. Inc. an Illinois components (the "Games") made by Midland Foods, Inc., an Illinois corporation (the "Second Note"), due in the manner as provided therein and in any event on the 31st day of July, 1996, payable to the order of Mortgagee, the terms and provisions of which Second Note are incorporated herein and made a part hereof by this reference with the same effect as if set forth at length."

The term "Second Note" as used in the Mortgage and hereinbelow, shall refer to the \$250,000.00 Term Note dated May 1, 1995 described in the preceding paragraph.

Mortgagor acknowledges and agrees that the Mortgage is and as amended hereby shall remain in full force and effect, and that the Premises are and shall remain subject to the lien granted and provided for by the Mortgage as amended hereby, for the benefit and security of all Incebtedness Hereby Secured, including, without limitation, the indebtedness evidenced by the First Note and the Second Note.

Without limiting the foregoing, the Mortgagor hereby agrees that, notwithstanding the execution and delivery hereof: (i) all rights and remedies of the Mortgages under the Mortgage, the First Note, the Second Note, and all other ocuments and instruments executed in connection therewith (hereinarter collectively the "Mortgage Documents"), (ii) all obligations and indebtedness of the Mortgagor thereunder, and (iii) the lien granted and provided for thereby, are and as amended hereby shall remain in full force and effect for the benefit and security of the Indercodness Hereby Secured, including, without limitation, the indebtocress evidenced by the First Note and the Second Note, it being specifically understood and agreed that this Agreement shall constitute and be an acknowledgment and continuation of the rights, remodies, and lien in favor of the Mortgagee, and the obligations and indebtedness of the Mortgagor to the Mortgages, which exist under the Mortgage Documents, as amended hereby, each and all of which are and shall remain applicable to the Premises.

This Agreement confirms and assures a continuing lien against the Premises heretofore granted in favor of the Mortgagee under the Mortgage, and nothing contained herein shall in any manner impair the priority of such lien.

Nothing contained in this Agreement shall in any manner impair the Mortgage, as modified hereby, or the first lien created by the Mortgage, or any other Mortgage Documents, or alter, waive, vary or affect any promise, agreement, covenant or condition recited in any

of the foregoing documents, except as expressly provided in this Agreement, or affect or impair any rights, powers, or remedies of Mortgages under any of the foregoing documents.

- 5. In order to induce the Mortgagee to enter into this Agreement, the Mortgager hereby represents and warrants to the Mortgagee that as of the date hereof, each of the representations and warranties set forth in the Mortgage Documents as amended hereby are true and correct and the Mortgagor is in full compliance with all of the terms and conditions of the Mortgage Documents as amended hereby and no event of default as defined in the Mortgage Documents as amended hereby, or any other event which with the lapse of time, the giving of notice or both would constitute such an event of default, has occurred and is continuing.
- 6. Except as specifically amended and modified hereby, all of the terms and conditions of the Mortgage Documents shall stand and remain unchanged and in full force and effect. This instrument shall be contrued and governed by and in accordance with the laws of the State of Illinois.
- 7. This Agreement shall be binding upon Mortgagor, its successors and assigns, and shall inure to the benefit of the Mortgages, its successors and assign.

IN WITNESS WHEREOF, Morraggor and Mortgagee have executed this Modification Agreement as of the day and year first above written.
