Kernedy and Heritage Trust Company U/T/A dated July 15, 1985, A/K/A Trust #85-2562 are indebted to the Bank in the total principal sum of One Hundred Twenty Five Thousand and 00/100 (\$125,000.00), as evidenced by a Secured Note ("Note") in the face amount of One Hundred Twenty Five Thousand and 00/100 (\$125,000.00) dated as of May 31, 1954, which Note is secured in part by a ("Mortgage and Assignment of Rents") applicable to the property commonly known as 4958 W. 162pd Street, Oak Forest, IL, 60452 legally described on "Exhibit I" attached hereto, which documents were dated May 31, 1994 and recorded with the Cook County Recorder of Deeds as Documents #94590130 and #94590131.
- B. Michael J. Kennedy and Heritage Trus'l Company U/T/A dated July 15, 1985, A/K/A Trust #85-2562 have requested an extension of the loan outlined above from June 1, 1995 to June 1, 1996. The Bank is willing to grant such an extension pursuant to the terms and provisions of this Agreement and the Promissory Note dated June 1, 1995 in the principal sum of One Hundred Twenty Five Thousand and 00/100 (\$125,000.00). (Replacement Note.)
