Restricts the premises as follows: lots to be for the use of single family private residence; maintenance of animals, livestock or poultry of any kind on property; dogs and cats under certain restrictions allowed; resubdividing of lots and location, size, and type of garage; side drives and vestibule construction; prohibits trailer, tent, shack, etc., and obnoxious trade or activity; and reserves an easement of 5 feet over rear of each lot for public utility installation and maintenance; advertising signs; height of fences and hedges and regulate care of trees and shrubs.
