(b) Grantor has the full power and right to enter into this Assignment and to hypothecate the Property; (c) Grantor has established adequate means of obtaining from Borrower on a continuing basis information about Borrower's financial condition, and (d) Lender has made no representation to Grantocabout Borrower (including without limitation the creditworthiness of Borrower)

GRANTOR'S REPRESENTATIONS AND WARRANTIES WITH RESPECT 10 THE RENTS. With respect to the Rents, Grantor represents and warrants to Lender that:

Ownership. Grantor is entitled to receive the Rents free and clear of all rights, loans, liens, encumbrances, and claims except as disclosed to and accepted by Lender in writing.

Control of the Contro

Right to Assign. Grantor has the full right, power, and authority to enter into this Assignment and to assign and convey the Bents to Lender.

No Prior Assignment. Grantor has not previously assigned or conveyed the Bents to any other person by any instrument now in force

No Further Transfer. Grantor will not sell, assign, encumber, or otherwise dispose of any of Grantor's rights in the Bents except as provided in this Agreement.

LENDER'S RIGHT TO COLLECT RENTS. Lender shall have the right at any time, and even though no default shall have excurred under this Assignment, to collect and receive the Rents. For this purpose, Lender is hereby given and granter the following rights, powers and authority.

Notice to Tenerts. Lender may send notices to any and all tenants of the Property advising them of this Assignment and sin ecting all Rents to be paid directly to Lender or Lender's agent.

Enter the Property Tender may enter upon and take possession of the Property; demand, collect and receive from the tenants or from any other persons liable therefor, all of the Rents; institute and carry on all legal proceedings necessary for the protection of the Property, including such proceedings as may be necessary to recover possession of the Property; collect the Rents and remove any tenant or tenants or other persons from the Property.

Maintain the Property. Lender dray enter upon the Property to maintain the Property and keep the same in repair; to pay the costs thereof and of all services of all employees, including their equipment, and of all continuing costs and expenses of maintaining the Property in proper repair and condition, and also to pay all taxes, assessments and water utilities, and the premiums on lire and other insurance effected by Lender on the Property.

Compliance with Laws. Lender may do any and all things to execute and comply with the laws of the State of illinois and also all other laws, rules, orders, ordinances and requirements of all other governmental agencies affecting the Property.

Compliance Default. Failure to comply with any other term, obligation, covenant or condition contained or this Assignment, the Note or in any of the Related Documents.

Default in Lavor of Third Parties. Should Borrower or any Grantor default under any loan restension of credit, security as element, purchase or sales agreement, or any other agreement, in favor of any other creditor or person that may materially affect any of Borrower's property or Borrower's or any Grantor's ability to repay the Loans or performance respective obligations under this Assignment or any of the Related Documents.

False Statements. Am worranty, representation or statement made or furnished to Lender by or on behalf of Grantor or Borrower under dus Assignment, the Note or the Related Documents is false or misleading in any material respect, either now or at the time made or furnished

Other Defaulta. Failure of crauter or Borrower to comply with any term obligation coverage or condition contained in any other agreemen, between Grantor or Borrower and Lendon

Death or insolvency. The death of Counter or Borrower or the dissolution or termination of Crantor or Borrower's existence as a going burnness, the insolvency of Grantor or Borrower, the appointment of a receiver for any part of Grantor or Borrower's property, any assignment for the benefit of creditors any type of creditor workout, or the commencement of any proceeding under any bankruptcy or insolvency laws by or against Grantor or Borrower.

Foreclosure, Forfeiture, etc. Commencement of foreclosure or forfeiture proceedings whether by policial proceeding, self-help, repossession or any other method, by any creditor of Grantor or by any governmental agency against any of the Property. Adverse Change. A material adverse change occurs in Borrower's financial condition, or Lender busieves the prospect of payment or performance of the Indebtedness is impaired.

Insecurity. Lender reasonably deems itself insecure.

RIGHTS AND REMEDIES ON DEFAULT. Upon the occurrence of any Event of Default and at any time thereafter tender may exercise any one or more of the following rights and remedies, in adultion to any either rights or remedies provided by law:

Accelerate Indebtedness. Lender shall have the right at its option without notice to Persower to declare the entire Indebtedness immediately due and payable, including any prepayment penalty which dorrower would be required to pay.

Collect Rents. Lender shall have the right, without notice to Grantor or Borrower, to take procession of the Property and collect the Rents, including amounts past due and unpaid, and apply the net proceeds over and above Lender's costs, against the Indebtedness. In furtherance of this right, Lender shall have all the rights provided for in the Lender's Right to Collect Section above. If the Rents are collected by Lender, then Grantor irrevocably designates. Lender as Grantor's attorney-in-fact to endorse instruments received in payment thereof in the name of Grantor and to negotiate the same and collect the proceeds. Payments by tenants or other users to Lender in response to Lender's demand shall satisfy the obligations for which the payments are made, whether or not any proper grounds for the demand existed. Lender may exercise its rights under this subparagraph either in person, by agent, or through a receiver.

Mortgagee in Possession. Lender shall have the right to be placed as mortgagee in possession or to have a receiver appointed to take possession of all or any part of the Property, with the power to protect and preserve the Property, to operate the Property preceding foreclosure or sale, and to collect the Bents from the Property and apply the proceeds, over and above the cost of the receivership, against the Indebtedness. The mortgagee in possession or receiver may serve without bond if permitted by law.
