BORROWER COVENANTS that Borrower is invitally seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property and that the Property is unencumbered, except for encumbrances of record. Borrower warrants and will defend generally the title to the Property against ell claims and demands, subject to any encumbrances of record.

4. Charges; Liens. - 8. Mortgage Insurance. - 13. Loan Charges.
