If, in the reasonable judgment of the Mortgagee, the Premises can be restored to an economic unit not less valuable than the same was prior to the condemnation and adequately securing the outstanding balance of the Indebtedness Hereby Securea, the award shall be used to reimburse the Mortgagor for the cost of restoration and rebuilding; provided, always, that Mortgagor is not in default hereunder, under the Loan Agreement, or the Note, and that no Event of Default has occurred and is then continuing.
