Insurance, including but not limited to hazard, business interruption and boiler insurance as Lender may require. Default. If all or any part of the Property is condemned by eminent domain proceedings or by any proceeding or purchase in lieu of condemnation, Lender may at its election require that all or any portion of the net proceeds of the award be applied to the Indebtedness or the repair or restoration of the Property. The net proceeds of the award shall mean the award after payment of all reasonable costs, expenses, and attorneys tees incurred by Lender in connection with the condemnation.

Proceedings. Taxes.
