- 1. The Mortgagor covenants and agrees as follows:
 - a. He will promptly pay the indebtedness evidenced by said promissory note at the times and in the manner therein provided.
- b. He will pay all taxes, assessments, water rates, and other governmental or mumicipal charges, fines, or impositions, for which provision has not been made hereinbefore, and will promptly deliver the official receipts therefor to the said mortgages.
- c. He will pay such expenses and fees as may be incurred in the protection and maintenance of said property, including the fees of any attorney employed by the mortgagee for the collection of any or all of the indebtedness hereby secured, or for foreclosure by mortgagee's sale, or court proceedings, or in any other litigation or proceedings affecting said premises. Attorneys' fees reasonably incurred in any other way shall be paid by the mortgagor.
- d. The mortgagor covenants and agrees that it he shall fail to pay said indebtedness or any part thereof when due, or shall fail to perform any covenant or agreement of this instrument or the promissory note secured hereby, the entire indebtedness hereby secured shall immediately become due, payable, and collectible without notice, at the option of the mortgages or assigns, regardless of maturity, and the mortgages or his assigns may before or after entry sell said property without appraisement (the mortgager having waived and assigned to the mortgages all rights of appraisement):
 - (1) at judicial sale pursuant to the provisions of 28 U.S.C. 2001 (a), or
