AGREED ORDER OF LIQUIDATION WITH A FINDING OF INSOLVENCY

THIS CAUSE COMING ON TO BE HEARD upon the Verified Complaint for an order directing MARK BOOZELL, Director of Insurance of the State of Illinois (the "Director"), to take possession and control of the property, business and affairs of SUPREME LIFE INSURANCE COMPANY OF AMERICA ("Supreme" or the "Company") and to liquidate Supreme pursuant to the provisions of Article XIII of the Illinois Insurance Code (the "Code") 215 ILCS 5/187 *et seq.*, for reason of insolvency; the Court having jurisdiction over the parties hereto and the subject matter hereof; the Court having reviewed the pleadings filed herein and having considered arguments of counsel thereon, and then being fully advised in the premises, and good cause appearing therefore;

THE COURT HEREBY FINDS:

1. Plaintiff, MARK BOOZELL, is the Director of Insurance for the State of Illinois and, in his official capacity, is charged under the Code, 215 ILCS 5/401 and under 20 ILCS

1405/56 with all of the rights, powers and duties appertaining to the enforcement and execution of the insurance laws of this State.

2. Defendant, Supreme, is a stock, legal reserve, life insurance company organized under and existing by virtue of the laws of the State of Illinois, having its principal place of business in Chicago, Illinois.

3. The Director filed a Verified Complaint for Liquidation With a Finding of Insolvency (the "Complaint") against Supreme.

4. By his Complaint, the Director seeks an order of liquidation as, to and against the Defendant, Supreme, pursuant to Section 188 of the Illinois Insurance Code, 215 ILCS 5/188. In his Complaint, the Director alleges that sufficient cause exists under Section 188 of the Code, *id.*, for the entry of such an order of liquidation against Supreme, including, *inter alia*, the following facts and circumstances:

- (a) Supreme is insolvent in an amount in excess of Two Hundred and Seven Thousand Dollars (\$207,000.00) and is impaired in an amount in excess of One Million Seven Hundred and Seven Thousand Dollars (\$1,707,000.00).
- (b) Supreme is unable to meet the requirements for organization and authorization as required by law.
- (c) Supreme is in such condition that the further transaction of its business would be hazardous to its policyholders, creditors and to the public.

- (d) Supreme, by a majority of its directors, stockholders or members, has consented to the commencement of Liquidation proceedings against it.

5. On or about June 30, 1995, a majority of the directors of Supreme passed and enacted a valid corporate resolution consenting to the entry of an Order of Liquidation with a Finding of Insolvency against Supreme and to the liquidation of Supreme by the Director pursuant to 215 ILCS 5/187 et seq.. Such consent is binding upon Supreme's agents, servants and employees and their successors.

6. Pursuant to 215 ILCS 5/190, the facts stated in the Complaint are taken as *prima facie* evidence of the facts recited therein and no evidence to the contrary having been offered, the Court finds therefrom as follows:

- (a) Sufficient grounds exist for the entry of an order of liquidation including, without limitation, the fact that Supreme is insolvent and impaired; that Supreme is unable to meet the requirements for organization and authorization as required by law; that Supreme is in such condition that the further transaction of business by Supreme would be hazardous to its policyholders, creditors and the public; and that Supreme, by a majority of its directors, has consented to the entry of such an Order.
- (b) That it is in the best interests of Supreme, its policyholders and creditors, and of the public, that Supreme be placed into liquidation in accordance with the provisions of Article XIII of the Code (*supra*).

7. That by entry of this Order with a finding of insolvency, the protections and provisions of the Illinois Life and Health Insurance Guaranty Association Law (215 ILCS 5/531.01 et seq.) are implemented effective the date of the entry of this Order.

NOW THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED THAT:

A. An Order of Liquidation With a Finding of Insolvency be and the same is hereby entered against Supreme Life Insurance Company of America.

B. MARK BOOZELL, Director of Insurance of the State of Illinois, and his successors in office, is hereby appointed Liquidator of Supreme and is directed to immediately take possession of the property, business and affairs of Supreme and of the premises occupied by it for the transaction of its business, as its Liquidator, and to liquidate the business and affairs of Supreme pursuant to the provisions of Article XIII of the Code, 215 ILCS 5/188 et seq.; to take such action as the nature of this cause and the interests of Supreme's policyholders, creditors, or the public may require, subject to the further orders of this Court.

C. The Director, as Liquidator, is hereby vested with title to all property, contracts, and rights of action of Supreme and he is authorized to deal with the property, assets, business and affairs of Supreme and to sue and defend for Supreme, or for the benefit of Supreme's policyholders and creditors in his name as the Liquidator of Supreme, or in the name of the Company.

D. The Director, as Liquidator, is vested with the rights, title and interest in all funds recoverable under treaties and agreements of reinsurance heretofore entered into by or on behalf of Supreme as the ceding insurer, and all reinsurance companies involved with Supreme are hereby enjoined from making any settlements with any claimant or policyholder of Supreme, or any other person, other than the Liquidator, except with the written consent of the Liquidator.

E. All banks, brokerage houses, and all other companies, entities or persons, having in their possession, assets which are, or may be, the property of Supreme are hereby enjoined from disbursing or disposing of said assets and all such persons and entities shall immediately turn over such assets to the Liquidator. Further, all such companies, persons and entities are hereby restrained and enjoined from disposing of, or destroying, any records pertaining to any

transaction between Supreme and banks, brokerage houses, and any other persons, entities or companies having done business, or doing business, with Supreme without the express consent of the Liquidator or the further order of this Court.

F. All of Supreme's agents and brokers, and their agents, brokers, employees and servants, are hereby enjoined from returning any unearned premiums, or any money in their possession collected as premiums on policies of insurance or contracts or treaties of reinsurance, to policyholders or others, and all said agents and brokers are directed to immediately turn over all such funds in their possession, or under their control, or which they may hereafter acquire, to the Liquidator in full and not net of any commissions they may be due thereon.

G. Supreme and its officers, directors, agents and employees, and all other persons are hereby enjoined and restrained from the further transaction of business of Supreme, or dealing with, or disposing of, the property or assets of Supreme, or doing, or permitting to be done, any action which might waste or conceal the assets of Supreme.

H. All persons, companies and entities are hereby enjoined from bringing, or further prosecuting, any action or claim for relief, counterclaim, set-off, cross-claim, third-party complaint, or otherwise, at law or in equity, or in any other proceeding, against Supreme, or its assets or property, or the Director as its Liquidator; from interfering, in any way, with the Director's conduct of the liquidation of Supreme or from obtaining preferences, judgments, or other like liens or encumbrances, or the making of any levy against Supreme or its property and assets while in the possession and control of the Liquidator; and from interfering, in any way, with the Liquidator in his right, title and interest to the property, books, records and all other assets of Supreme.

I. All persons are hereby enjoined from asserting any claim against Supreme, or its property or assets, or the Director as its Liquidator, except insofar as such claims arise in, or are brought in, the liquidation proceedings.

J. The rights and liabilities of Supreme, and of their creditors, policyholders, stockholders and all other persons interested in its assets are hereby fixed as of the date of the entry of this Order of Liquidation.

K. All persons, including, but not limited to, the policyholders of Supreme, and all persons asserting claims against such policyholders, are hereby enjoined from instituting or further pursuing any action or proceeding in any court or before any administrative agency, including boards and commissions administering worker's compensation or occupational diseases, or similar laws of the State of Illinois, or of any other state, or of the United States, which seek in any way, directly or indirectly, to contest or interfere with the Liquidator's exclusive right, title, and interest to funds recoverable under treaties and agreements of reinsurance heretofore entered into by or on behalf of Supreme as the ceding insurer.

L. Hereafter the caption in this cause and all pleadings in this matter shall read:

**"IN THE MATTER OF THE LIQUIDATION OF SUPREME
LIFE INSURANCE COMPANY OF AMERICA"**

M. This Order of Liquidation With a Finding of Insolvency shall be a final order within the meaning of Illinois Supreme Court Rule 307(a)(5).

N. The Director, as Liquidator, is hereby authorized to wind-down and terminate Supreme's business and affairs, and to make the continued expenditure of such wages, rents and expenses as he may deem necessary and proper for the administration of the liquidation of Supreme.

O. The Liquidator is hereby required to make periodic reports to the Court regarding the status of Supreme while in liquidation and to file with the Court, for its consideration, periodic reports of the Liquidator's receipts and disbursements of Supreme.

P. The Liquidator is hereby authorized to pay, from the assets of Supreme, those administrative expense incurred during the course of the liquidation of Supreme, including, but not limited to, attorneys' fees, accounting fees and consulting fees, as administrative expenses pursuant to and in a manner consistent with the provisions of 215 ILCS 5/202 with all such payments to be reported to the Court in his periodic reports of receipts and disbursements.

Q. The Director, as Liquidator, is hereby authorized to sell, at a reasonable price, any items of personal property of Supreme having a market value of the amount of Ten Thousand and 00/100 (\$10,000.00) Dollars, or less, without the prior approval of this Court and is further authorized to abandon or dispose of any items of personal property of Supreme having no sale value without the prior approval of this Court. Any such sale, abandonment or disposal of the personal property of Supreme shall be reported by the Director to the Court in his periodic reports of the receipts and disbursements of Supreme.

R. That all costs of these proceedings are hereby taxed and assessed against the Defendant, Supreme; and
