THE NOTE CONTAINS PROVISIONS ALLOWING FOR CHANGES IN THE INTEREST RATE AND THE MONTHLY PAYMENT. THE NOTE LIMITS THE AMOUNT THE BORROWER'S INTEREST RATE CAN CHANGE AT ANY ONE TIME AND THE MINIMUM AND THE MAXIMUM RATE THE BORR DWER MUST PAY.

ADDITIONAL COVENANTS. In addition to be covenants and agreements made in the Security Instrument, Horrower and Lender further covenant and agree as follows:
