GRANTOR'S REPRESENTATIONS AND WARRANTIES. Maintain the Property. Lender may enter upon the Property to maintain the Property and keep the same in repair; to pay the costs thereof and of all services of all employees, including their equipment, and of all continuing costs and expenses of maintaining the Property in proper repair and condition, and also to pay all taxes, assessments and water utilities, and the premiums on fire and other insurance effected by Lender on the Property.

Other Defaults. Failure of Grantor or Borrowar to comply with any term, obligation, covenant, or condition contained in any other agreement between Grantor or Borrower and Lender.

Death or Insolvency. The death of Grantor or Sucrower or the dissolution or termination of Grantor or Borrower's existence as a going business, the insolvency of Grantor or Borrower, the appointment of a receiver for any part of Grantor or Borrower's property any assignment for the benefit of creditors, any type of creditor workout, or the commencement of any proceduring under any bankruptcy or insolvency laws by or against Grantor or Borrower.
