WHEREAS, on December 4, 1992, the Cifice of Thrift Supervision (MOTSM) by Order No. 92-509 closed CARYERET SAVINGS BANK, FA ("CARTERET") (Successor to Centeret Savings and Loan Association, F.A. and Carteret Savings and Loan Association) and declared it insolvent and appointed the Resolution Trust Corporation ("RTC") as its sole receiver (the "Receiver") for the purpose of Cinuidation.

WHEREAS, on December 4, 1992, also by Orler Mo. 92-509 the OTS created and chartered a new federal mutual savings association known as CARTERET FEDERAL S.VI. IGT BANK ("CARTERET FEDERAL") and the RTC was appointed as

Conservator for CARTERET FEDERAL (the "Conservator"). WHEREAS, on December 4, 1992, the RTC in its capacity, as the Receiver of CARTERET entered into a Purchase and Assumption Agreement with RTC in its capacity as Conse vatur for CARTERET FEDERAL whereby substantially all of the assets, including the right, title and interest to the wortgage described herein, was transferred, assigned,

conveyed and delivered to CARTERET FEDERAL. WHEREAS, by operation of law, the Conservator has succeeded to all of the rights, title, powers and privileges of CARTERET FEDERAL, and, therefore, the Conservator is the present owner and holder of the mortgage described herein and the Conservator hereby acknowledges full payment and soft faction of said note and mortgage and

surrenders the same as canceled and hereby direct the Recorder of Cerds to cancel the same of record.
