Sections 9601-9675. In the course of that cleanup, a decision was reade, with the consent of the then current owner, to allow lead contaminated soil to remain under a concrete foundation located in the northeastern portion of the property, and under a concrete foundation beneath a metal shredding process located in the center-east portion of the property. Both concrete foundations must be retained in perpetuity to limit exposure to lead contaminated soils."

Such lien may be enforced in any manner that the court may order.
