SECOND MODIFICATION OF MORTGAGE

This Agreement entered into as of June 15, 1995 by and between JOHN MALEC and RHONDA MALEC, husband and wife (the "Mortgagor"), and LASALLE NATIONAL BANK, a national banking association (the "Mortgagee"), having an address at 120 South LaSalle Street, Chicago, Illinois 60603.

RECITALS:

- A. Mortgagor executed a Mortgage (the "Mortgage") dated January 27, 1993 and recorded on February 5, 1993 as Document No. 93098589 in the Office of the Cook County Recorder of Deeds (the "Recorder of Office"), as modified by a Partial Release of Mortgage dated June 1, 1994 releasing the property commonly known as 600 West Stratford Place, Chicago, Illinois, as modified by a First Modification of Mortgage dated June 1, 1994 and recorded on July 7, 1994 as Document No. 94589059 with the Recorders Office and as modified herein and encumbering certain property commonly known as 577 West Hawthorne Place, Chicago, Illinois and as more particularly described in Exhibit A attached hereto (the "Premises");
- B. The Mortgage secures that certain Note dated January 27, 1993 signed by John Males in the original principal amount of \$1,200,000, as extended by an Extension Note dated December 1, 1993 in the principal amount of \$1,200,000 and as modified and extended by a Modification Note dated as of even date herewith in the principal amount of \$2,000,000 signed by John Males and Rhonda Males (collectively, which such notes, together with any and all extensions, renewals and modifications thereof and substitutions therefor, is referred to herein as the "Note");
- C. The Note bears interest prior to maturity or the occurrence of a Default at the rate of interest announced from time to time by Mortgagee as its Prime Rate (the "Interest Rate") and following maturity or the occurrence of a Default at the Interest Rate plus two percent '(2%);

NOW, THEREFORE, in consideration of the foregoing, the parties hereby agree as follows:

- 1. <u>Note Secured</u>. (a) The term "Note", as defined in the Mortgage, is hereby amended to be the Note as defined herein.
- (b) Mortgagor expressly agrees that the Mortgage secures the Note, any and all extensions, renewals and modifications thereof and substitutions therefor, and any other sums, liabilities or indebtedness as set forth in the Mortgage.
- 2. <u>Continuing Effect</u>. All the terms of the Mortgage are hereby incorporated by reference herein, and the Mortgage, except as hereby modified, shall remain in full force and effect in all respects. Mortgagor, by execution of this Agreement, hereby
