MORTGAGE

THIS MORTGAGE IS DATED AUGUST 1, 1995, between Michael LaValle, whose address is 250 Arthur, Roselle, IL 60172 (referred to below as "Grantor"); and Aldwest Bank and Trust Company, whose address is 501 West North Avenue, Melrose Park, IL 60160 (referred to below as "Lender").

GRANT OF MORTGAGE. DEFINITIONS. The following words shall have the following meanings when used in this Mortgage. Unless prohibited by law or agreed to the contrary by Lender in writing, Grantor shall reimburse Lender for all costs and expenses incurred in connection with the matters referred to in this paragraph.

Attorney-in-Fact. If Grantor fails to do any of the things referred to in the preceding paragraph, Lender may do so for an in the name of Grantor and at Grantor's expense.
