- 2. Sale or Transfer of Premises or Interest Therein. Mortgager agrees and understands that it shall constitute an event of default under this Mortgage and the Note entitling the remedies herein and in the Note to be exercised if (a)

the Mortgagor, or any beneficiary of the Mortgagor, shall convey title to, or beneficial interest in, or otherwise suffer or permit any equitable or beneficial interest in the premises to become vested in any person or persons, firm or corporation or other entity recognized in law or equity other than the Mortgagor or the present beneficiary or beneficiaries, (b) allow any line or security interest to attach to the premises or the beneficial interest in the premises other than the lien of this Mortgage, excluding taxes and assessments not yet due and payable, (c) any articles of agreement for deed or other installment contract for deed, title or beneficial interest or land contract in the premises are entered into, or (d) any partnership interest of a partnership, if any, owning all or a portion of the beneficial interest in the Mortgagor is convoyed, transferred, or hypothecated, in whole or in part.

- 3. Payment of Taxes. Mortgagor shall pay before any penalty attaches all real estate taxes, and shall pay special taxes, special assessments, water charges, newer service charges, and other charges against the promises when due, and shall upon written request, furnish to Mortgagee duplicate receipts therefor. To prevent default hereunder, Mortgagor shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagor may desire to contest.
- 4. Insurance, Mortgagor shall keep all haildings and improvements now or hereafter situated on said premises insured, until the indebtedness secured by this Mortgage is fully paid, or in case of forcelesure, until the expiration of any period of redemption, against loss or daying by fire and such other hazards as may reasonably be required by Mortgagee, including, without limitation on the generality of the foregoing, war damage insurance whonever in the opinion of Mortgagee such protection is necessary. Mortgagee shall also provide liability insurance with such limits for personal injury and death and property damage as Mortgagee may require and if required by Mortgagee, flood and rents (which will assure coverage for loss of rental income for twelve (12) consecutive months) in urance. All policies of insurance to be furnished herounder shall be in forms, companies and amounts satisfactory to Mortgagee, that in no event less than the amount needed to pay in full the indebtedness secured hereby) with mortgagee clauses attached to all policies in favor of and in form satisfactory to Mortgagee, including a provision requiring that the coverage evidenced the oby shall not be terminated or materially modified without ten (10) days' prior written notice to the Mortgagee. - 5. Tax and Insurance Deposits. To more fully protect the socurity of this Mortgage and to provide security to the Mortgage for the payment of real estate taxes and insurance prevalents, Mortgager agrees to pay to Mortgager, at such place as Mortgager may from time to time in writing appoint and in the almence of such appointment, then at the office of the Mortgager in Chicago, Illinois, each month at the due date for the manifold for under the Note) in an amount as provided for under the Note (in addition to paying the principal and interest provided for under the Note) in an amount as determined by Mortgager, in such manner as the Mortgager may prescribe, to provide security for the payment of the real estate taxes and insurance premiums.

If the funds so deposited exceed the amount required to pay such taxes for any year, the excess shall be applied on a subsequent deposit or deposits. The Mortgagor further agrees that Mortgagor shall not be required to make payments for which insufficient funds are on deposit with the Mortgagor. Mortgagor agrees that nothing herein contained shall be construed as requiring the Mortgagee to advance other movies for such purpose and the Mortgagee shall not incur any liability for anything it may do or omit to do.

Neither Mortgagor nor, to the best knowledge of Mortgagor, any other person or entity has over mused or permitted, and Mortgagor will not at any time cause or permit, a Reportable Quantity (as hereinafter defined) of Hazardous Material (as hereinafter defined) to be placed, hold, located or disposed of on, under or at the premises, or to be transported from the premises and unlawfully placed, held, located or disposed of on, under or at any other site or property (by whomsoever owned), or to be released in to the atmosphere or any watercourse, body of water or wetlands, or to be disposed of in any place or manner which, with the passage of time or the giving of notice or both, would give rise to liability for potential liability) under any Environmental Laws (as here reafer defined). Neither the premises nor any part thereof, has over been used (whether by Mortgagor or, to the best knowledge of foretgagor, by any other person or entity), and Mortgagor will not use or permit the premises, or any part thereof, to be used, as a treatment, storage or disposal (whether permanent or temporary) site for any Hazardous Material.

Notwithstanding anything to the centrary in this Mortgage, the Note or any other instrument or document, the provisions of and undertakings and indemnification set out in this provision shall survive the satisfaction and release of this Mortgage and the payment and satisfaction of all indebtedness secure of by this Mortgage, and shall continue in effect forever.

"Hazardous Material" means and includes any hazardous, toxic or dangerous substance or any pollutant or contaminant defined as such in. or for purpose of, any Environmental Laws. "Environmental Laws" means the Comprehensive Environmental Response, Compensation, and Liebelly Act, any so-called "Superfund" or "Superlien" law, the Resource Conservation and Recovery Act, the Clean Water Act, and Toxic Substances Control Act, the Illinois Responsible Property Transfer Act or any other existing or future federal, six to an local stature, law, ordinance, code, rule, regulation, order or decree, regulating, relating to, or imposing liability or standards of conduct or remediation concerning any hazardous, toxic or dangerous waste, substance or material, each as now or hereafter in effect.

7. Mortgageo's Interest In and Use of Deposits. In the event of a default in any of the provisions contained in this mortgage or in the Note, the Mortgageo may at its option, without being required to do so, apply any moneys at the time on deposit pursuant to paragraph 5 hereof, as any one or more of the same may be applicable, on any of Mortgagor's obligations herein or in the Note contained, in such order and manner as the Mortgageo may elect. When the indebtedness secured hereby has been fully paid, any remaining deposits shall be paid to Mortgagor or to the then owner or owners of the mortgaged premises within a reasonable period of time. - 8. Mortgageo's Right to Act. If Mortgagor fails to pay any claim, lien or encumbrance which shall have a prior lien to the lien of this indenture, or to pay, when due, any tax or assessment, or any insurance premium, or to keep the premises in repair, as aforesaid, or shall commit or permit waste, or if there be commenced any action or proceeding affecting the promises or the title thereto, then Mortgagee, at its option, may pay such claim, lien, encumbrance, tax, assessment or premium, with right of subrogation thereunder, may procure such abstracts or other evidence of title as it deems necessary, may make such repairs and take such steps as it deems advisable to prevent or cure such waste, and may appear in any such action or proceeding and retain counsel therein, and take such action therein as Mortgagee deems advisable, and for any of such purposes Mortgagee may advance such sums of money as it deems necessary. Mortgagee shall be the sole judge of the legality, validity and priority of any such claim, lien, encumbrance, tax, assessment and promium, and of the amount necessary to be paid in satisfaction thereof. Mortgager will pay to Mortgagee, immediately and without demand, all sums of money advanced by Mortgagee pursuant to this paragraph, together with interest on each such advance at the rate set forth in the Note, and all such sums and interest thereon shall be secured hereby.
- Adjustment of Losses with Insurer and Application of Proceeds of Insurance. In case of loss, the Mortgagoo (or after entry of decree of forceleaure, purchaser at the sale, or the decree creditor, as the case may be) is hereby authorized citier (a) to settle, collect, compromise and adjust, in its discretion any claim under such insurance policies without consent of Martgagor, or (b) to allow Mortgagor to agree with the insurance company or companies on the amount to be paid upon the loss. In either case Mortgagee is authorized to collect and receipt for any such insurance money. Mortgagor agrees to sign, upon degrand by Mortgagoe, all rescipts, vouchers and releases required of him by the companies. If (a) Mortgagor is obligated to resect our replace the damaged or destroyed buildings or improvements under the terms of any lonse or lonses which are or may be prior to the lien of this Mortgage, (b) such damage or destruction does not result in cancellation or termination of such lesse, (c) the insurers do not deny liability as to the insureds, and (d) such proceeds are sufficient to restore or replay the damaged or destroyed buildings or improvements in the judgement of Morgagee, such proceeds, after deducting thereit om any expenses incurred in the collection thereof, shall be used to reimburse Mortgagor for the cost of rebuilding or costoration of buildings and improvements of said promises. In all other cases, such insurance proceeds may, at the option of Mortgagee, either be applied in reduction of the indebtedness secured hereby, whether due or not, or be held by the Mortgage values to reimburse Mortgagor for the cost of the rebuilding or resteration of buildings or improvements on said promises. At such time as the Mortgagor is not in default either under the terms of the Note or under the terms of this Mortgage, the Mortgagor shall have such privilege of making prepayments on the principal of the Note (in addition to the required payments) as may be provided in the Note, and in accordance with the terms and conditions, if any, set forth in the Note.
- 12. Effect of Extensions of Time.
