LYTHR SOUTH OF THE SOUTH LINE OF ARCHER AVENUE AND EAST AND NORTHEAST OF THE EAST LINE OF CORK AVENUE, AS CONVEYED IN COURT CASE 6069975. AND THAT PART OF THE WEST HAUF OF THE SOUTHWEST QUARTER (EXCEPT THE SOUTH 33 FEET THEREOF TAKEN FOR 79TH STREET) OF SECTION 26.
