

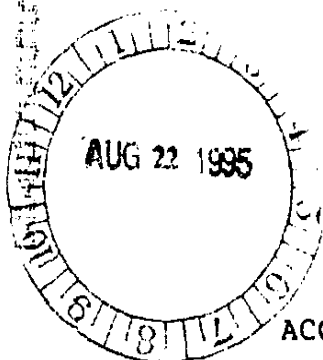

## LEGAL DESCRIPTION

THAT PART OF THE SOUTHEAST QUARTER OF SECTION 27, TOWNSHIP 38 NORTH, RANGE 12 EAST OF THE THIRD PRINCIPAL MERIDIAN, LYING SOUTH OF THE SOUTH LINE OF ARCHER AVENUE AND EAST AND NORTHEAST OF THE EAST LINE OF CORK AVENUE, AS CONVEYED IN COURT CASE 6059975, AND THAT PART OF THE WEST HALF OF THE SOUTHWEST QUARTER (EXCEPT THE SOUTH 33 FEET THEREOF TAKEN FOR 79TH STREET) OF SECTION 26, TOWNSHIP 38 NORTH, RANGE 12 EAST OF THE THIRD PRINCIPAL MERIDIAN, LYING SOUTH OF THE SOUTH LINE OF ARCHER AVENUE; TOGETHER WITH LOT 4 (EXCEPT THE NORTH 660 FEET THEREOF) AND THAT PART OF LOT 5, LYING SOUTH AND SOUTHEASTERLY OF THE EXISTING CENTER LINE OF ARCHER ROAD (EXCEPT THAT PART OF THE NORTH 1.2746 ACRES OF SAID LOT LYING EAST OF ARCHER ROAD, AND NORTH OF CENTER OF DITCH TO THE SOUTH, AND EAST OF A LINE DRAWN FROM A POINT IN THE EASTERLY LINE OF ARCHER ROAD, 52 FEET SOUTHWESTERLY OF THE INTERSECTION OF THE NORTH LINE OF SAID LOT 5 AND THE EASTERLY LINE OF SAID ARCHER ROAD, SOUTHEASTERLY AT AN ANGLE OF 48 DEGREES 14 MINUTES, A DISTANCE OF 46.8 FEET TO THE CENTER OF DITCH CONVEYED TO THE CATHOLIC BISHOP OF CHICAGO BY WARRANTY DEED RECORDED JUNE 10, 1904, AS DOCUMENT 3550942 AND EXCEPT FURTHER THAT PART OF LOT 5 AFORESAID CONVEYED TO ERNST HUNDERLICH BY WARRANTY DEED RECORDED JULY 11, 1904, AS DOCUMENT 3553653) IN COBURN'S SUBDIVISION OF THE EAST HALF OF THE NORTHWEST QUARTER, THE EAST HALF OF THE SOUTHWEST QUARTER AND THE WEST HALF OF THE SOUTHEAST QUARTER OF SECTION 26, TOWNSHIP 38 NORTH, RANGE 12 EAST OF THE THIRD PRINCIPAL MERIDIAN, ALL IN COOK COUNTY, ILLINOIS, AND CONTAINING 94.125 ACRES, MORE OR LESS, THEREIN.
