GEORGE E. STOURTON, P.L.S., being duly sworn on oath deposes and says that he is a Professional Land Surveyor of the State of Illinois, and

That he prepared a plat of HARCOURT MEADOWS SUBDIVISION, said plat having been recorded with the Cook County Recorder of Deeds on November 23, 1994 as Document 94994415, and

That said subdivision is a subdivision of Lot 1 in Block 4 in Arthur T. McIntosh and Co's Southtown Farms, Unit 6, and

That Lots 2, 3, and 4 in said Block 4, together with adjacent lands was, at the time of platting, owned by the same owner, and

That the land East of Lot 13, Harcourt Meadows Subdivision, South of Harcourt Street (60 feet wide), North of a line 160 feet South of and parallel to the South line of said Harcourt Street, and West of the East line of what is now platted as Outlot B, Indian Boundary Subdivision, according to the plat thereof recorded as Document No. 94975500, is and was also known as OUTLOT A, HARCOURT MEADOWS SUBDIVISION, and by an error in drafting, such designation was not applied to the plat presently of record, and

The plat of record is hereby amended to show the correct designation of the property East of said Lot 13, as described above, as OUTLOT A, HARCOURT MEADOWS SUBDIVISION.

This correction shall in no way be construed to correct or modify whatsoever, Lots 1 through 13, Harcourt Meadows Subdivision.
