- 1. Subordinating Party further agrees that:

- 1. Any future advance of funds or additional debt that may be secured by Subordinating Party's mortgage shall be subject to the provisions of this Mortgage Subordination Agreement.
- 2. The mortgage securing the note in favor of Lender, and any renewals, extensions, or modifications of it, will be and shall remain a lien on the Property prior and superior to any lien for future advances of funds or additional debt secured by Subordinating Party's mortgage.
