MODIFICATION AGREEMENT (Mortgage)

This Modification Agreement is effective as of the 3/5+day of , 1995, between American National Bank and Trust Company of Chicago as Trustee Under Trust Agreement Dated October 5, 1994 and Known as Trust No. 118866-03, an Illinois Land Trust, hereinafter referred to as "Mortgagor" and AMERICAN NATIONAL BANK AND PUST COMPANY OF CHICAGO, hereinafter referred to as "Lender".

WITNESSETH

WHEREAS, on December 8, 1994, Mortgagor executed in favor of Lender, a Mortgage (the "Mortgage") subsequently recorded on December 13, 1994 in Cook County, Illinois as Document Number 04040602, concerning real estate, legally described in Exhibit "A" attached hereto and incorporated herein. The Mortgage was given by Mortgagor to secure payment to Lender of a Mortgage Note dated December 8, 1994, in the principal sum of TWO HUNDRED FORTY FIVE THOUSAND AND 00/100 DOLLARS (\$245,000.00) and other Collateral Loans as defined in Section XXIV. Exhibit "B" of said Mortgage (hereinafter collectively the "Original Notes").

WHEREAS, Raymond F. Lazzara ("Lazzara") has executed a new Note dated as of 31, 1995, in the principal sum of ONE HUNDRED NINETY FIVE THOUSAND AND 00/100 DOLLARS (\$195,000.00). This Note, along with the Original Notes are collectively referred to hereinafter as the "Note", with such other amendments, modifications, renewals, or replacements thereof.

WHEREAS, Lender has agreed to a substitution of collateral for the Collateral Loans.

WHEREAS, the parties hereto have agreed upon a modification of the terms and conditions of the Mortgage as herein set forth.

Now therefore, in consideration of the premises and the mutual promises and agreements hereinafter made by and between the parties hereto, the said parties do hereby mutually agree to modify the Mortgage as follows:

- 1. Exhibits B-1, B-3(a) and B-3(b) are hereby deleted.
- 2. The amount of the Mortgage is hereby increased to THREE HUNDRED FORTY THOUSAND AND 00/100 DOLLARS (\$340,000.00).
- 3. The Mortgage securing the Note is a valid and subsisting lien on the premises described in the Mortgage.

The parties hereto further mutually agree that all provisions, stipulations, powers and covenants in the Note and in the Mortgage contained, except as medified by this Modification Agreement, shall stand and remain unchanged and in full force and effect for and during said extended period, except only as specifically varied or amended above; and further that in the event of a failure to pay the same principal sum as herein provided, or to keep, fulfill or perform any or all of the covenants and agreements contained in the Mortgage, then the whole of said principal sum shall, at the election of the holder of the Note, become at once, without notice, due and payable and may be collected together with all accrued interest and collection costs thereon, in the same manner as if this modification had not been granted, anything hereinbefore to the contrary notwithstanding.

It is expressly understood and agreed by and between the parties hereto that the covenants and agreements herein contained shall bind and inure to the benefit of the respective heirs, executors, administrators, legal representatives and assigns of the said parties hereto.
