That on October 6, 1994, DILIP T. SINGHI and SANTOSH D. SINGHI, owned the following legally described land located in the County of Cook, State of Illinois, to wit:

That on October 6, 1994, Claimant entered into a certain contract for the sum of THREE THOUSAND NINE HUNDRED DOLLARS (\$3,900.00) with DILIP T. SINGHI, one of the owners of the premises, who was permitted and knowingly authorized by the other owners to enter into said contract to do electrical installation of switches, circuits, jacks and other such electrical installations as required by contract, and to supply labor, services, materials and permits for the same on an addition of said premises. Claimant began the work on May 3, 1995. Claimant was directed by DILIP T. SINGHI, who in addition, acted as his own general contractor, and last furnished labor services and material on June 23, 1995.

That the owners have paid Claimant FIVE HUNDRED DOLLARS (\$500.00) as a partial payment under the contract, and are entitled to credits toward said contract in said amount.

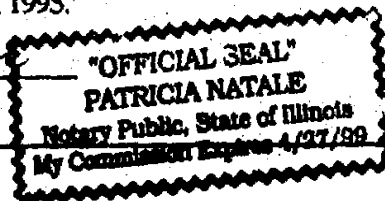
That there remains unpaid, due and owing Claimant the sum of ONE THOUSAND SEVEN HUNDRED TEN DOLLARS AND TWENTY CENTS (\$1710.20) plus interest for which Claimant claims a lien on the subject land and improvements.
