Notwithstanding the foregoing, this Assignment of Rents shell be deemed a present assignment.

All rights and remedies of Association hereunder shall be in addition to all other rights and remedies granted to Association under any instrument evidencing or further securing the indebtedness secured hereby. Such rights and remedies may be exercised concurrently or in such befor and at such times as Association in its sole discretion may elect. The failure to exercise any right or remedy shall not be sort to ed as a waiver or release of said right or remedy or of the right to exercise thom at a later date.
