#### ORDINANCE

# ESTABLISHING SPECIAL SERVICE AREA NO. 21 IN THE CITY OF PARK RIDGE, COOK COUNTY, ILLINOIS, AND PROVIDING FOR OTHER PROCEDURES IN CONNECTION THEREWITH

WHEREAS, the Constitution of the State of Illinois, 1970, and 35 ILCS 235/0.01 et seq. establish the authority of municipalities to designate special service areas within the boundaries of home rule municipalities; and

VHEREAS, as the result of a continuous public planning effort for the redevelopment of Park Ridge, there has been the public expression of support for the creation of a special service area for improvement of a public alley; and

WHEREAS, the City Council of the City of Park Ridge, a home rule municipality, finds:

- A. That it is in the public interest that there be created the area hereinafter described as a special service area for the purpose set forth herein;
- B. That said area is situated entirely within the City of Park Ridge and is contiguous;
- C. That said area will benefit specially from the improvements to be provided, in addition to any benefit to the City of Park Ridge as a whole, and it is, therefore, in the best interest of the City of Park Ridge that a tax be levied in said (2021) for the improvements to be provided; and

WHEREAS, a public hearing was held on the 17th day of Actil. 1995 in the Council Chambers of the City Hall, 505 Butler Place, Park Ridge, Illinois, pursuant to Ordinance No. 95-14 to consider the creation of Special Service Area No. 21 of the City of Park Ridge, and

WHEREAS, notice of said hearing was given as required by 35 ILCS 235/0.01 et seq in substantially the form set forth in Ordinance No. 95-14;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Park Ridge, Cook County, Illinois, that City of Park Ridge Special Service Area No. 21 is hereby established consisting of the territory described below and shown in the map attached hereto as Exhibit A, being the same territory described in Ordinance 95-14 and in the public notice.

The area bounded by Albion on the south, Gillick on the north, Courtland on the east, and Prospect on the west.

BE IT FURTHER ORDAINED that a special tax, in addition to all other taxes, may be levied at the annual rate of not to exceed \$1.42 per \$100 of assessed equalized valuation of taxable property in the area, to provide revenue for improving the public alley in the area.

BE IT FURTHER ORDAINED that the City Council shall have sole discretion as to how the revenues of the Special Service Area shall be used within the scope of its purpose.

BE IT FURTHER ORDAINED that the City Manager is hereby authorized and directed to take such step, 22 are necessary to effectuate the provisions of this ordinance.

This ordinance shall be in full force and effect from and after its adoption and approval as provided by law, providing on petition is filed opposing creation of the Special Service Area, pursuant to 35 ILCS 235/9.

BE IT FURTHER ORDAINED that the City Clerk is hereby authorized and directed to publish said ordinance in pamphlet form according to law.
