AN ORDINANCE

1994-42

VACATING A CERTAIN PUBLIC STREET IN THE VILLAGE OF NILES, ILLINOIS

BE IT ORDAINED by the President and Board of Trustees of the Village of Niles, Cook County, Illinois, as follows:

SECTION 1: That it is hereby determined that the interests will be served by vacating the public street legally described as follows:

That part of Golf Road as dedicated per Document Number 10298769 recorded March 4, 1929) lying North of and peljoining Lots 69, 70 and 71 on Golf Greenwood Gardens Syndivision, being a Subdivision of the North West Quarter of the North West Quarter of Section 14, Township 41 North, Range 12 East of the Third Principal Meridian, according to the Plat thereof recorded June 6, 1919, in Cook County, Illinois

in the Village of Niles, Cook County, Illinois.

SECTION 2: That the Village of Niles reserves unto itself and unto any public utility in said street, any and all easements, rights of way and rights of entry as in the judgment of the corporate authorities are necessary or desirable for continuing public service by means of sewer, water and drainage lines and public utilities and for the maintenance, genewal, relocation, reconstruction, enlargement and extension thereof.

SECTION 3: That the public street described in Section 1 of this Ordinance and shown on the Plat attached hereto, be and the same, is hereby vacated.

SECTION 4: That the Village Clerk is horeby directed to file for record in the office of the Recorder of Deeds of Cook County, Illinois, a certified copy of this ordinance including the Plat of Vacation which is made a part hereof.
