Whereas, on May 11, 1987, Second National Building and Loan, Salisbury, Maryland converted from a state charter to a federal charter and the name was changed to Second National Federal Savings Bank; and

Whereas, on December 4, 1992, the OTS by Order No. 92-511 appointed the RTC as Conservator for Second National Federal Savings Association.

Whereas, on September 16, 1994, the OTS by Order No. 94-169 replaced the RTC as Conservator with RTC as Receiver for Second National Federal Savings Association.

Therefore, pursuant to the aforesaid OTS Orders and by Operation of Law pursuant to 12 U.S.C. §1821(d)(2)(1989) and 12 U.S.C. §1441a(b)(1991), the RTC as Conservator for Second National Federal Savings Association succeeded to all right, title, and interest in and to the assets, including, without limitation, the promissary note and the mortgage, deed of trust or security deed for the loan referenced above, with full power to transfer and convey same.
