- (f) Impositions: All real estate and personal property taxes and other taxes and assessments, public or private; water and ewer rates and charges; all inspection fees required under Article IV, 4.9; all other governmental or nongovernmental charges pplicable to the Mortgaged Property; any interest or costs or penalties with respect to any of the foregoing; and charges for any assement or agreement maintained for the benefit of the Mortgaged Property, general and special, ordinary and extraordinary, foreseen and unforeseen, of any kind and nature whatsoever which may at any time prior to or after the execution of this Mortgage, be assessed, evied, or imposed upon the Mortgaged Property or the rent or income received therefrom, or any use or occupancy thereof.

- (j) <u>Leases</u>: Any and all leases, licenses, concessions or grants of other possessory interests granted by Mortgagor as le low or hereafter in force, oral or written, covering or affecting all or any part of the Mortgage Property.
 - (k) Mortgaged Property: The Land, the Improvements, the Fixtures and the Leases together with:
- (1) all rights, privileges, rents, royalties, profits, mineral, oil and gas rights and profits, tenements, hereditaments, ights-of-way, easements, appendages, appurtenances, riparian or littoral rights now or hereafter belonging or in any way appertaining to the Land and/or the Improvements;
- (2) all of Mortgagor's right, title and interest in and to any streets, rights-of-way, alleys, strips or gores of land now or hereafter adjoining the Land;
- (3) all of Mortgagor's right, title and interest in and to any awards heretofore made or hereafter to be made by any nunicipal, county, state or federal authority or board to the present and all subsequent owners of the Land and/or the Improvements and/or the Fixtures and/or the Personal Property, including any award or awards for any change or changes of grade of any street or treets affecting the Land and/or the Improvements and/or the Fixtures and/or the Personal Property, subject to Mortgagor's right to se such award pursuant to Article VIII; and
- (4) all the estate, right, title, interest, claim or demand whatsoever of Mortgagor, either at law or in equity, in and to be Land and/or the Improvements and/or the Fixtures.

- (1) Obligations: Any and/or all of the covenants, promises and other obligations (other than for the payment of the Indebtedness) including, without limitation, the payment of Impositions as provided herein made or owing by Mortgagor or others to or due to Mortgagee under and/or set forth in the Agreement and/or the Security Documents.
 - (in) Personal Property: All personal property owned by Morrgagor and located on the Land.
- (n) Proceeds: All monies and proceeds derived from the Personal Property or from said Mortgaged Property including. without limitation, insurance proceeds and condemnation awards.
- (o) Rents: All the rents, revenues, income, profits and other benefits now or hereafter arising from the use and enjoyment of the Mortgaged Property.
- (p) Security Documents. The Agreement and all other documents and instruments now or hereafter furnished to Morrgagee, including, but not limited to, this Mortgage, to evidence or secure payment of the Indebtedness.

ARTICLE II **GRANT**

2. Grant of Security Interest.

- 2.1 Grant. To secure the payment of the Ind bledness and the performance and discharge of the Obligations, Mortgagor does by these presents give, transfer, bargain, sell, alien, remis, release, assign, mortgage, hypothecate, deposit, pledge, set over, confirm, convey, warrant and grant a security interest unto Mortgag e n and to all estate, right, title and interest of Mortgagor in and to the Mortgaged Property, whether now owned or held or hereafter acquired by Mortgagor to have and to hold the Mortgaged Property unto Mortgagee, its successors and assigns, forever.
- 2.2 Condition of Grant. The condition of the grant in Paragraph 2.1 above is such that if Mortgagor shall pay or cause to be paid the Indebtedness as and when the same shall become due and payable and shall observe, perform and discharge the Obligations, then the Security Documents and the estates and rights granted by them shall would and void, otherwise to remain in full force and C/OPA'S OPEN effect.

ARTICLE III REPRESENTATIONS

3. Representations. Mortgagor hereby represents to Mortgagee that:

3.1 Validity of Security Documents:

- (a) The execution, delivery and performance by Mortgagor of the Security Documents, and the lor owing evidenced by the Agreement, will not, to the best of Mortgagor's knowledge, violate any provision of law, any order of any court or other agency of government, or any Mortgage, indenture, trust agreement or other instrument to which Mortgagor is a party in any material aspect or by which it or any of its property is bound, or be in conflict with, or will result in a material breach of or constitute (with due notice and/or lapse of time) a default under any such Mortgage, indenture, trust agreement or other instrument, or result in the creation or imposition of any lien, charge or incumbrance of any nature whatsoever upon any of its property or assets, except as contemplated by the provisions of the Security Documents; and
- (b) The Security documents, as and when executed and delivered by Mortgagor, constitute the legal, valid and binding obligations of Mortgagor in accordance with their respective terms subject to applicable bankruptcy and insolvency laws.

- 3.2 Other Information: All other information, reports, papers and data given to Mortgagee, or to Mortgagee's legal counsel, with respect to Mortgagor, the Mortgaged Property, or the loan evidenced by the Security Documents are accurate and correct in all material respects and complete insofar as completeness may be necessary to give Mortgagee a true and accurate knowledge of the subject matter.
- 3.3 Mortgaged Property and Other Property: Mortgagor has good and marketable title in fee simple to the Land free and clear of all encumbrances except for the First Mortgage and other encumbrances of record as of the date of this Mortgage. Mortgagor will preserve its title to the Mortgaged Property and will forever covenant and defend the same to Mortgagee and will forever covenant and defend the validity and priority of the lien of this Mortgage.
- 3.4 First Mortgage: Mortgage does hereby acknowledge that the only mortgage lien that is prior or, in any way, superior to this Mortgage is the first Mortgage.
- 3.5 Taxes: To the best of its knowledge, Mortgagor has filed all federal, state, county and municipal income tax returns required to have been filed by them/it and has paid all taxes which have become due pursuant to such returns, pursuant to any assessments received by it or pursuant to law, and the Mortgagor does not know of any basis for additional assessment in respect of such taxes or additional taxes.
- 3.6 <u>Litigation</u>: There is not now pending against or affecting the Mortgaged Property, nor, to the knowledge of Mortgagor, is there threatened or contemplated, any action, suit or proceeding at law or in equity or by or before any administrative agency which, if adversely determined, would materially impair or affect the value or operation of the Mortgaged Property.
- 3.7 Environmental Indemnity: Mortgagor that indemnify and hold Mortgagee harmless against and from any and all loss, cost, damage, claim or expense (including, without limitation, any and all attorney's fees or expenses of litigation) incurred or suffered by Mortgagee on account of (i) the location on the Land in Improvements of any chemical, material, substance, or contaminant (including, without limitation, oil, petroleum products, asbestos, ure a, formaldehyde, foam insulation, hazardous waste and/or toxic waste), the presence or storage of which or the exposure to which is prohibited, limited, or regulated by any federal, state, county, regional or local government unit, agency or authority, or which presence, storage or exposure may pose a hazard to health and safety, or (ii) the failure of Mortgagor or any prior owner or occupant of the triand to comply with any applicable federal, state, county, regional or local environmental laws, regulations and court or administrative orders.

ARTICLE IV AFFIRMATIVE COVENANTS

- 4. Affirmative Covenants. Until the entire Indebtedness shall have been paid in full, Mortgag in hereby covenants and agrees as follows:
- 4.1 Compliance With Laws: Mortgagor shall promptly and faithfully comply with, conform to and obey or contest by appropriate proceedings in good faith all present, and use its best efforts as to future, laws, ordinances, rules, regulations and requirements of every duly constituted governmental authority or agency and of every board of fire underwriters in virg jurisdiction, or similar body exercising functions, which may be applicable to it or to the Mortgaged Property or to the use and manner of use, occupancy, possession, operation, maintenance or reconstruction of the Mortgaged Property, whether or not such law, ordinance, rule, order, regulation or requirement shall necessitate structural changes or improvements or interfere with the use or enjoyment of the Mortgaged Property.
- 4.2 <u>Payment of Impositions</u>: Mortgagor shall duly pay and discharge, or cause to be paid and discharged, the Impositions prior to any penalty or default date. Mortgagor may exercise the option to pay the same in installments.
- 4.3 Repair: Mortgagor shall keep the Mortgaged Property in good order and condition and make all necessary or appropriate repairs, replacements and renewals thereof.

4.4 Insurance:

- (a) At all times during the term of this Mortgage, Mortgagor shall carry or cause to be carried policies insuring the Mortgaged Property against loss of rents or business interruption and against loss or damage by fire, theft, vandalism, malicious mischief, hazards and such other risks as Mortgagee may from time to time require, including, without limitation, those risks included in the term 'extended coverage'. The amount of the coverage afforded by each of the Insurance Policies shall be in amounts reasonably satisfactory to the Mortgagee and shall be sufficient to prevent any insured from becoming a co-insurer of a partial loss thereunder, but in any case no such amount shall be less than either (1) full replacement cost of all Improvements, or (2) the outstanding Indebtedness, whichever amount is greater at the time of the loss or damage.
- (b) All Insurance Policies shall, at all times, be in form, substance and with companies acceptable to Mortgagee; bear a non-contributory first nortgage endorsement and such other endorsements in form and content acceptable to Mortgagee in favor of Mortgagee or as Mortgagee may request,; and shall remain in force, with renewals and replacements thereof, which renewals and replacements shall be dejosited with Mortgagee with evidence of payment of all premiums no later than fifteen (15) days prior to the expiration of any then existing Insurance Policy, until the Indebtedness is paid in full. Every Insurance Policy shall contain an agreement that no party there o may terminate or modify the Insurance Policy without at least 15 days prior written notice to Mortgagee.
- (c) Premiums on all Insulance Policies shall be paid by the Mortgagor and payment shall be made promptly and when due directly to the insurance carrier. Mortgagee may, but shall not be obligated to, make premium payments to prevent lapse or cancellation by reason of nonpayment of premium, and any amounts so paid by Mortgagee shall be treated as 'Advances' in accordance with paragraph 4.15.
- 4.5 Application of Insurance Policy Proceeds: In case of loss, damage or casualty to the Mortgaged Property, the proceeds of claims under the Insurance Policies covering casualty losses or an ages shall be paid to Mortgagee for application, at the option of Mortgagee, either (i) to the Indebtedness, (in the inverse order of maturity) with the balance of such proceeds, if any, paid to Mortgagor, or (ii) to the restoration of the Mortgaged Property on such conditions and subject to such controls as Mortgagee may impose in its absolute discretion, with the balance of such proceeds, if any, applied (in the inverse order of maturity) against such Indebtedness. Notwithstanding any other provision of this Mortgage or the Agreement, no application of Insurance Policy proceeds to the Indebtedness shall have the effect of curing any Event of Default or extending the time for making any payment hereunder or under the Agreement. Mortgagee shall not be held responsible for failure to collect any invariance proceeds due under the terms of any policy provided for herein regardless of the cause of such failure.
- 4.6 Restoration Following Uninsured Casualty: In the event of the happening of any resulty, of any kind or nature, ordinary or extraordinary, foreseen or unforeseen, not covered by any Insurance Policy resulting in damage to or destruction of the Mortgaged Property, Mortgagor shall give notice thereof to Mortgagee and Mortgagor shall promptly, at Mortgagor's sole cost and expense, commence and diligently continue to restore, repair, replace, rebuild or alter the damaged or destroyed Mortgaged Property as nearly as possible to its value, condition and character immediately prior to such damage or destruction.
- 4.7 <u>Value</u>: Mortgagor shall use its best efforts to prevent any act or thing which might materially and reversely impair the value or usefulness of the Mortgaged Property.
- 4.8 <u>Performance of Other Agreements</u>: Mortgagor shall duly and punctually perform all covenants and agreements expressed as binding upon it under any agreement of any nature whatsoever binding upon it that involves the Mortgaged Property including, without limitation, all rules and regulations of a homeowners or condominium association if the Mortgaged Property is part of a condominium cooperative, phased development or other homeowners association.
- 4.9 <u>Inspection</u>: Mortgagor shall permit Mortgagoe, and parties designated by Mortgagoe, at all reasonable times, to inspect the Mortgagod Property upon three (3) days' prior written notice.

- 4.10 Hold Harmless: Mortgagor shall, at Mortgagor's sole cost and expense, save, indemnify and hold the Mortgagee, its s, officials, employees and agents, harmless from any injury, claim, demand, suit, judgment, execution, liability, debt, damage alty (hereinafter collectively referred to as 'Claims') affecting the Mortgaged Property, or the value of any of the Security ents, arising out of, resulting from, or alleged to arise out of or result from, any action or inaction by Mortgagor, except as may direct result of Mortgagee's negligence. Mortgagor shall pay all expenses incurred by Mortgagee in defending itself with regard and all Claims. These expenses shall include all out-of-pocket expenses, such as attorneys' and experts' fees, and shall also the reasonable value of any services rendered by any employee of the Mortgagee.
- 4.11 Expenses: Mortgagor shall pay or reimburse Mortgagee for all reasonable attorneys' fees, reasonable costs and expenses incurred by Mortgagee in any action, proceeding or dispute of any kind in which Mortgagee is made a party or appears as party f or defendant, involving any of the Security Documents, Mortgagor, or the Mortgaged Property, including, without limitation, oreclosure or other enforcement of this Mortgage, any condemnation involving the Mortgaged Property, any action to protect the hereof, or any proceeding in probate or bankruptcy, and any such amounts paid or incurred by Mortgagee shall be treated as ces' in accordance with Paragraph 4.15.
- 4.12 Payment of Indebtedness: Margagor shall timely pay and discharge the Indebtedness or any part thereof in accordance terms and conditions of the Agreement, this Mortgage, and the Security Documents.
- 4.13 Flood Disaster Protection Act: Mortgagee shall take all steps necessary to comply with the provisions of the Flood r Protection Act of 1973, as amended and, if required by Mortgagee, Mortgagor shall cause the Mortgaged Property to be pursuant to the provisions of such Act.
- 4.14 First Mortgage: Mortgagor shall comply with all terris, provisions and conditions of the First Mortgage.
- 4.15 Advances: In the event Mortgagor fails to perform any act required of Mortgagor by any of the Security Documents or then due any amount required to be paid by any of the Security Documents, Mortgagee may, but shall not be obligated to, make yment or perform such act. Such payment or performance by Mortgagee shall not have the effect of curing any Event of or of extending the time for making any payment due hereunder or under to Agreement. All amounts so paid by Mortgagee. with all expenses incurred in connection therewith, shall be deemed advances ('Advances') under this Mortgage, shall be stely due and payable and shall be added to the Indebtedness. Advances shall bear interest from the date expended at the rate I in the Agreement and shall be secured by this Mortgage as though originally a part of the principal amount of the ness. OH'S

ARTICLE V NEGATIVE COVENANTS

tive Covenants. Until the entire Indebtedness shall have been paid in full, Mortgagor covenants and agr. es as follows:

- 5.1 Use Violations: Mortgagor shall not use the Mortgaged Property or allow the same to be used or excupied for any purpose or in violation of any permit or certificate, or any law, ordinance, regulation or restrictive covenant, covering or to the use or occupancy thereof, or suffer any act to be done or any condition to exist on the Mortgaged Property or any article 📞 ought thereon, that may be dangerous, unless safeguarded as required by law, or that may, in law, constitute a nuisance, sublic 👽
- 5.2 Alterations: Mortgagor shall not commit or knowingly permit any waste of the Mortgaged Property or make or permit to any material alterations or additions to the Mortgaged Property that would have the effect of materially diminishing the value or that will in any way materially increase the risk of any ordinary tire or other hazard arising out of construction or operation

- 5.3 Replacement of Fixtures, Improvements and Personal Property: Mortgagor shall not permit any of the Fixtures or Improvements to be removed at any time from the Land, without the prior written consent of Mortgagee, unless actually replaced by an article of equal or greater suitability and value and owned by Mortgagor.
- 5.4 Other Liens: Mortgagor shall not, without the prior written consent of Mortgagee, create or permit to be created or to remain, any mortgage, pledge, lien, encumbrance or charge on, security interest in, or conditional sale of or other little retention agreement on (whether prior or subordinate to the liens of the Security Documents) the Mortgaged Property or income therefrom other than the Security Documents and the First Mortgage.
- 5.5 Transfer of Title: As a material inducement to Mortgagee to make the loan evidenced by the Agreement and secured by this Mortgage, Mortgagor has made representations to Mortgagee concerning the abilities of the undersigned in constructing, managing and operating the Mortgaged Property, which representation have been and will be relied upon by Mortgagee in funding this loan. Therefore, Mortgagor covenants and agrees that it will not sell, convey, transfer, alienate, pledge, encumber or permit to be sold, conveyed, transferred, alienated, pledged or encumbered the Mortgaged Property and will not convey or assign any beneficial interest in the Mortgaged Property, without the prior written consent of the Mortgagee, which consent may be granted or withheld in Mortgagee's sole discretion, and if granted may be conditioned upon any successor of Mortgagor agreeing to an increase in the interest rate in the Agreement.
- 5.6 Sale or Lease of the Mortgage Troperty: If Mortgagor contracts to sell or Lease all or any portion of the Mortgaged Property or amends, modifies or terminates any new existing or future sales contract. Lease, or other agreement concerning the Mortgaged Property, Mortgagor will furnish Mortgagee with a copy of the executed contract, Lease or agreement within 15 days after the date of execution thereof.

ARTICLE VI EVENTS OF DEFAULT

- 6. Events of Default. The term 'Event of Default', as used in the Security Documents, shall mean the occurrence or happening, from time to time, of any one or more of the following:

 6.1 False Representations: If Mortgagor engages in traud c.

 6.2 Performance of Obligations: If Mortgagor defaults in the payment of the Indepteum.

 Agreement.

 6.3 Adverse Actions: If Mortgagor's actions or inactions adversely affect the Mortgager's Property or Mortgager's rights thereto and interest therein.

ARTICLE VII REMEDIES

7.1 Remedies: If an Event of Default shall occur and be continuing, Mortgagee may, at its option, after previding Mortgagor with at least a 30 days advance notice of, and opportunity period to cure, the Event of Default, exercise any, some or all of the following remedies:

- 7.1.1 Acceleration: Mortgagee may declare the unpaid portion of the Indebtedness to be immediately due and payable, without further notice or demand (each of which is hereby expressly waived by Mortgagor), whereupon the Indebtedness shall become immediately due and payable, anything in the Agreement or in the Security Documents to the contrary notwithstanding; provided further that the unpaid portion of the Indebtedness shall be immediately and automatically due and payable without action of any kind on the part of the Mortgagee.
- 7.1.2 Enforcement of Mortgage: Mortgagee, with or without entry, personally or by its agents or attorneys, insofar as applicable, may:
- (a) sell the Mortgaged Property and all estate, right, title and interest, claim and demand therein, and right of redemption thereof, to the extent permitted by and pursuant to the procedures provided by law, at one or more sales, and at such time and place upon such terms and right of required or permitted by law;
 - (b) institute proceedings for the complete foreclosure of this Mortgage;
- (c) take steps to protect and enforce its rights whether by action, suit or proceeding in equity or at law for the specific performance of any covenant, condition or agreement in the Agreement or in this Mortgage, or in and of the execution of any power herein granted, or for any foreclosure increunder, or for the enforcement of any other appropriate legal or equitable remedy or otherwise as Mortgagee shall elect; and/or
 - (d) enforce this Mortgage in any other manner permitted under the laws of the State of Illinois.
- 7.1.3 <u>Receiver</u>: Mortgagee may apply to the count in which a proceeding is pending for the enforcement of this Mortgage to have a receiver appointed to enter upon and take possession of the Mortgaged Property, collect the rents and profits therefrom and apply the same as the court may direct; such receiver to have all or the rights and powers permitted under the laws of the State in which the Mortgaged Property is situated. The right to the appointment of such receiver shall be a matter of strict right without regard to the value or the occupancy of the Mortgaged Property or the solvency or insolvency of the Mortgagor. The reasonable expenses, including receiver's fee, counsel's fees, costs and agent's commission, incurred patharpt to the powers herein contained shall be secured hereby.
- 7.2 Other: If Mortgagor defaults in the due observation or performance of any of the Obligations in accordance with this Mortgage, Mortgagee may exercise any remedy available to Mortgagee under applicable law.
- 7.3 Remedies Cumulative and Concurrent: The rights and remedies of Mortgag et as provided in the Security Documents shall be cumulative and concurrent and may be pursued separately, successively or together against Mortgagor, Guarantor or the Mortgaged Property, or any one of them, at the sole discretion of Mortgagee, and may be exercised as often as occasion therefor shall arise, all to the maximum extent permitted by applicable laws, rules and regulations. If Mortgagee elects to proceed under one right or remedy under this Mortgage or the Agreement, Mortgagee may at any time cease proceeding under such right or remedy and proceed under any other right or remedy under this Mortgage or the Agreement. The failure to exercise any such right or remedy shall in no event beconstrued as a waiver or release thereof. Nothing in the Agreement or this Mortgage shall affect Mortgagor's obligations to pay the Indebtedness and perform the obligations in accordance with the terms thereof.
- 7.4 <u>Credit of Mortgagee</u>: Upon any sale made under or by virtue of this Article VII, whether made under the power of sale herein granted or by virtue of judicial proceedings or of a judgment or decree of foreclosure and sale. Mortgagee may bid for and acquire the Mortgaged Property and in lieu of paying cash therefor may make settlement for the purchase price by crediting upon the Indebtedness the amount of Mortgagee's bid.

- 7.5 No Conditions Precedent to Exercise of Remedies: Neither Mortgagor nor any other person now or hereafter obligated for t of all or any part of the Indebtedness shall be relieved of such obligation by reason of the failure of the Mortgagee to comply request of Mortgagor or any other person so obligated to take action to foreclose on this Mortgage or otherwise enforce any ns of this Mortgage or the Agreement, or by reason of the release, regardless of consideration, of all or any part of the security the Indebtedness, or by reason of any agreement or stipulation between any subsequent owner of the Mortgaged Property and ee extending the time of payment or modifying the terms of this Mortgage or Agreement without first having obtained the of Mortgagor or such other person; and in the latter event Mortgagor and all such other persons shall continue to be liable to syment according to the terms of any such extension or modification agreement, unless expressly released and discharged in by Mortgagee.

- that if any of the rights waived by Mortgagor in this paragraph, affect or extend the time for sale or the Mortgaged Property, ortgagee's rights to enforce this Mortgage or affect Mortgagor's right to redeem, Mortgagee shall have the right to elect to reject the waiver of such right by Mortgagor, and such election may be made by Mortgagee at the time of or at any time prior ry of a decree or judgment of foreclosure in the court in which this Margage is being foreclosed.
- 7.7 Discontinuance of Proceedings: In case Mortgagee shall have proceeded to enforce any right under any of the Security its and such proceedings shall have been discontinued or abandoned for any review, then in every such case. Mortgagor and e shall be restored to their former positions and the rights, remedies and powers of Mortgagee shall continue as if no such gs had been taken. Off,

ARTICLE VIII CONDEMNATION
