6. If Borrower fails to perform the covenants and agreements contained in this Mortgage, or if any aution or proceeding is commenced which materially affects Lender's interest in the Property, including, but not limited to, eminent domain, insolvency, code enforcement, or arrangements or proceedings involving a bankrupt or decedent, then Lender at Lender's option, upon notice to Borrower, may make such appearances, disburse such sums and take such action as is necessary to protect Lender's interest, including, but not fimited to, disbursement of reasonable attorney's fees and entry upon the Property to make repairs.
